LOCAL GOVERNMENT ETC (SCOTLAND) ACT, 1994 THE DUMBARTON AND CLYDEBANK COUNCIL DESIGNATION 1995

The Council noted that in terms of the Dumbarton and Clydebank Council Designation 1995 of 22nd March, 1995 signed on behalf of the Secretary of State Mr. Robert G. Ward was authorised to convene the first meeting of the Dumbarton and Clydebank Council.

INTERIM CHAIRMAN

Mr. Neil MacIntosh, as Returning Officer for the Dumbarton and Clydebank Elections, acted as Chairman of the meeting.

DUMBARTON AND CLYDEBANK COUNCIL ELECTION 1995 – REPORT BY RETURNING OFFICER

There was submitted and noted report by the Returning Officer on the Dumbarton and Clydebank Election 1974, a copy of which had previously been issued to each member of the Council, details of which were appended to the Minute of this meeting.

DECLARATION OF OFFICE

The Interim Clerk advised the Council that all members of the Council had signed the Declaration of Acceptance of Office.

STANDING ORDERS

It was reported that the Secretary of State had designated the Standing Orders to apply for the first meeting of the Council be the Standing Orders for the regulation of proceedings and business of Dumbarton District Council.

The Council agreed that the Standing Orders be adopted by the new Council subject to consideration be given to minor amendments to the Standing Orders later in the meeting.

ELECTION OF CONVENER

The Returning Officer invited nominations for the appointment of a Convener. Councillor Campbell, seconded by Councillor Cairney, moved that Councillor Patrick O'Neill be appointed as Convener of the Council. By way of an amendment, Councillor Mackechnie, seconded by Councillor McElhill moved that Councillor Mrs Margaret McGregor be appointed as Convener of the Council.

On a vote being taken, seven members (Councillors McElhill, Wailes, Mackechnie, McLaughlan, McColl, Mrs McGregor and Chirrey) voted for the amendment and fifteen members (Councillors O'Neill, Campbell, McCafferty, Syme, White, Devine, MacDonald, Doherty, Rice, Cairney, Kemp, McCallum, Calvert, Mills and Flynn) voted for the motion which was declared carried.

Mr Neil McIntosh vacated the Chair.

Councillor Patrick O'Neill took the Chair and thanked all members for the support and for the confidence in appointing him to the office of Convener of the Council.

APPOINTMENT OF DEPUTE CONVENER

Nominations were invited for the appointment of a Depute Convener.

Following consideration, Councillor McCafferty, seconded by Councillor Mills, moved that Councillor George Cairney be appointed as Depute Convener of the Council. By way of an amendment, Councillor Mackechnie, seconded by Councillor Mrs. McGregor, moved that Councillor McElhill be appointed as Depute Convener of the Council.

On a vote being taken, seven members (Councillors McElhill, Wailes, Mackechnie, McLaughlan, McColl, Mrs. McGregor and Chirrey) voted for the amendment and fifteen members (Convener O'Neill and Councillors Campbell, McCafferty, Syme, White, Devine, MacDonald, Doherty, Rice, Cairney, Kemp, McCallum, Calvert, Mills and Flynn) voted for the motion which was declared carried.

Councillor Cairney was appointed as Vice Convener of the Council and invited to take his place beside the Convener.

LEADER OF THE COUNCIL

The Council were asked whether they wished to appoint a Leader of the Council.

Following consideration, Convener O'Neill, seconded Councillor Doherty, moved that Councillor Mary Campbell be appointed as Leader of the Council. By way of an amendment, Councillor Mackechnie, seconded by Councillor McElhill, moved that the post of Leader of the Council be not filled.

On a vote being taken, seven members (Councillors McElhill, Wailes, Mackechnie, McLaughlin, McColl, Mrs. McGregor and Chirrey) voted for the amendment and fifteen members (Convener O'Neill and Councillors Campbell, McCafferty, Syme, White, Devine, MacDonald, Doherty, Rice, Cairney, Kemp, McCallum, Calvert, Mills and Flynn) voted for the motion which was declared carried.

Councillor Mary Campbell was appointed as Leader of the Council.

At this stage of the proceedings, the Council agreed to adjourn for a short period to allow the press to take a photograph of the new Council.

Mr. Neil McIntosh now left the meeting.

Following the adjournment, the Council dealt with the business as follows:-

INTERIM CLERK

The Council were advised that the Council required to appoint a suitable person to act as Interim Clerk in respect of subsequent meetings pending the availability of permanent staff. It was also recommended by COSLA that the Interim Clerk should also be the Interim Monitoring Officer.

Following consideration, the Council unanimously agreed that Mr. Robert G. Ward should continue to act as Interim Clerk and Interim Monitoring Officer on the terms approved by the Secretary of State.

INTERIM FINANCE OFFICER

It was recommended that an Interim Finance Officer should be appointed and authorised to open up and operate bank accounts and deal with Election Members' expenses and allowances, etc. The Finance Officers of Dumbarton and Clydebank Joint Working Group had considered this matter and it was understood that Mr. Duncan Blackie, Depute Director of Finance, Strathclyde Regional Council, would be willing to act as Interim Finance Officer should the Council so desire.

Following consideration, the Council unanimously agreed to appoint Mr. Duncan Blackie as Interim Finance Officer.

FINANCING OF NEW COUNCIL

There was submitted Finance Circular No. 15/1995 dated 7th April, 1995 from the Local Government Finance Group of the Scottish Office (previously circulated) entitled "Local Government Re-organisation: Distribution of Grant to Shadow Councils". The Council noted that the Scottish Office proposed to distribute to them in the next 12 months a total grant of £906,000 payable in monthly instalments commencing April 1995.

The Council noted that the payments for the months of April and May would be made on 26th April, 1995.

ADVICE TO NEW COUNCILS

There was submitted letter dated 7th April, 1995 to the Convener of the Council from the Chairman, Local Government Staff Commission (Scotland), together with relative enclosure (previously circulated).

There was also submitted copy of a letter dated 7th April, 1995 from the President of the Convention of Scottish Local Authorities and COSLA papers entitled "Advice to New Councils - 1. The First Meeting" and 2. Appointment of Head of Paid Services, together with letter dated 12th April, 1995 with enclosure from COSLA regarding Advisers.

The position was noted at this stage.

FINAL REPORT OF THE DUMBARTON AND CLYDEBANK JOINT WORKING GROUP

There was submitted a copy of the Final Report of the Dumbarton and Clydebank Joint Working Group (previously circulated). There was also submitted a supplementary paper prepared on a tripartite basis by the Officers of Clydebank and Dumbarton District Council entitled "Draft Urban Programme and Urban Aid - Draft Note for Shadow Authority" (previously circulated).

Following consideration, the Council agreed that the Report be continued meantime.

There was submitted and noted letter dated 12th April, 1995 from the Sub-Regional Officer, Dumbarton Sub-Region (previously circulated) regarding information meetings, seminars, etc. and the Council agreed that it would be their intention that the Head of Paid Services, when appointed, would arrange such meetings.

RE-ORGANISATION COMMITTEE

The Council were asked whether they wished to appoint a Committee (possibly Ad Hoc) with full delegated powers to deal with practical problems and authorise urgent action where necessary. Members were reminded that COSLA had suggested that an Interim Executive Committee be appointed for this purpose comprising one third of members and including the Convener, Depute Convener and Leaders of the majority and minority Groups.

COSLA had recommended that the remainder of the membership should be chosen to achieve presentation reflecting party allegiance, geography and tender.

Following consideration, the Council agreed that this matter be continued to the next full meeting of the Council.

ARRANGEMENTS FOR FUTURE MEETINGS OF THE COUNCIL

The Council were reminded that they would require to set a date and time for the next meeting. It was recommended that the next meeting should be solely for the purpose of the appointment of the Chief Executive/Head of Paid Service.

The Council, at this time, were asked to consider the venue for their future meetings. Strathclyde Regional Council had indicated that the Council Chambers, Sub-Regional Offices, Garshake Road, Dumbarton could easily be made available for this purpose. The Regional Council had also indicated that they would arrange for a room to be made available (to all parties) in order that the Councillors could carry out their duties. The room will be on the Committee Room floor and some desks and telephone facilities would be available. Strathclyde Regional Council could provide secretarial assistance if required. The Council were also asked to consider whether they would wish, at this stage, a room to be made available for the Convener/Leader of the Council and whether secretarial assistance was required.

Strathclyde Regional Council had also indicated that they could make available throughout the building, as and when required, rooms in order that group discussions could take place if required. During a full Council meeting it was anticipated that 25 car parking spaces would be made available for members use and during normal days 10 spaces could be made available.

Following consideration, the Council in noting the position agreed that this matter be continued for consideration at the next full Council meeting.

NOTICES OF MOTION

A Notice of Motion had been received from Councillor William Mackechnie (SNP), Group Leader, in the following terms:-

"That the Dumbarton and Clydebank Council endorses fully and unequivocally the aims of the Zero Tolerance Campaign and called on all Councillors to sign a declaration to that effect." This was seconded by Councillor Mrs. McGregor. By way of an amendment, Councillor Campbell, seconded by Councillor White, moved as follows:-

"Dumbarton and Clydebank Council endorses fully and unequivocally the aims of the Zero Tolerance Campaign and will continue to build on this support given by Clydebank and Dumbarton District Councils".

On a vote being taken, seven members (Councillors McElhill, Wailes, Mackechnie, McLaughlin, McColl, Mrs. McGregor and Chirrey) voted for the motion and fifteen members

(Convener O'Neill and Councillors Campbell, McCafferty, Syme, White, Devine, MacDonald, Doherty, Rice, Cairney, Kemp, McCallum, Calvert, Mills and Flynn) voted for the amendment which was declared carried.

A Notice of Motion had been received from Councillor William Mackechnie (SNP), Group Leader, in the following terms:-

"That the Dumbarton and Clydebank Council join Nuclear Free Local Authority Scotland and the Dumbarton and Clydebank Council support the arms conversion project". This was seconded by Councillor Wailes. By way of an amendment, Councillor Campbell, seconded by Councillor McCafferty moved as follows:-

"That confirmation of the Labour Manifesto commitment, Dumbarton and Clydebank Council will maintain Labour policies on Nuclear Free Zones. In addition, while fully recognising the contribution defence workers make to the local economy, Dumbarton and Clydebank will support the arms conversion project".

On a vote being taken, seven members (Councillors McElhill, Wailes, Mackechnie, McLaughlin, McColl, Mrs. McGregor and Chirrey) voted for the motion and fifteen members (Convener O'Neill and Councillors Campbell, McCafferty, Syme, White, Devine, MacDonald, Doherty, Rice, Cairney, Kemp, McCallum, Calvert, Mills and Flynn) voted for the amendment which was declared carried.

LOCAL AUTHORITIES ETC (ALLOWANCES) (SCOTLAND) REGULATIONS 1995

There was submitted Circular No. 11/1995 of 12th April, 1995 from the Environment Department, The Scottish Office (previously circulated) entitled "Local Authorities Etc. (Allowances) (Scotland) Regulations 1995. There were submitted the following reports (previously circulated) which had been prepared by the Finance Working Group:-

1. Scheme of Members' Allowances.
2. Members' Travel and Subsistence Allowances.

As regards the Scheme of Members' Allowances, the Council agreed to opt for the basic allowance to take no action regarding the attendance allowance and that the special responsibility allowances be considered at a future meeting of the Council.

With regard to the report on Members' Travel and Subsistence Allowances, the Council agreed as follows:-

1. that the draft List of Approved Duties as submitted be approved for the purpose of travelling and subsistence subject to there being added thereto attendance at meetings of Tenants' Organisations and School Board and also Surgeries;
2. that travel by train for Councillors, Chief Officers and other Officers authorised by them should be at first class fares subject to second fares for Scotland;

3. that the passenger supplement by paid in respect of carrying additional passengers and reimbursement should be made of the cost incurred of toll, ferries and parking fees;
4. travel by air should be at the discretion of the Councillors, Chief Officers or other Officers authorised by them, taking into account the circumstances of the duty with the allowance being the ordinary fare or any available cheap fare actually paid which ever is less;
5. approval of travel and subsistence rates as outlined in the report and approval of the ready reckoner as the basis for applying the allowances; and
6. payment of travel and subsistence allowances would be made, together with payment of basic allowances. However, in appropriate circumstances, advances of expenses may be arranged.

It was further agreed that a report on reimbursement of telephone rentals and business calls be submitted to a future meeting, together with indication of the practice of three existing authorities.

After hearing the Interim Clerk, the Council noted that arrangements had been made, should the members so wish, for an advancement of £250 for each of the months of April and May and an advancement of £100 subject to a top-up if necessary in respect of travel and subsistence allowances. It was noted that these allowances would be in a payroll system by June and that any monies due would be adjusted in the June payment.

The Council were advised that insurance cover had already been taken out for the Council and members agreed to homologate the action taken.

SCHOOL BOARDS

There was submitted letter dated 13th April, 1995 with enclosure from the Education Department, The Scottish Office, (previously circulated) entitled "The School Board - A Consultation Paper by the Scottish Education Department".

Following consideration, the Council noted the position at this stage and agreed that the Regional Council be asked for their comments thereon.

LOCAL GOVERNMENT ETC (SCOTLAND) ACT, 1994 THE STRATHCLYDE COMBINED POLICE AREA AMALGAMATION SCHEME

There was submitted letter dated 13th April, 1995 with enclosure from the Home and Health Department, The Scottish Office (previously circulated) in connection therewith.

Following consideration, the Council noted the position at this time and agreed to continue the matter for consideration at a future meeting.

1995/96 BUDGETS FOR NEW COUNCIL***

Following consideration, the Council noted the position at this stage and agreed that the matter be considered at a future meeting of the Council.

ADMINISTRATION SCHEME***

There was submitted letter dated 21st April, 1995, together with enclosure referred to therein received from the Home and Health Department, The Scottish Office (previously circulated) in connection therewith.

Following consideration, the Council noted the position at this stage and agreed that the matter be continued for consideration at a future meeting of the Council.

STANDING ORDERS

The Convener reminded the Council that they had agreed to consider the Standing Orders.

After hearing Councillor Campbell, the Leader of the Council, the Council agreed that this matter be continued for consideration at a future meeting of the Council.

EXCLUSION OF PRESS AND PUBLIC

The Council unanimously agreed to pass the following Resolution:-

"That under Section 50A(4) of the Local Government (Scotland) Act, 1973, the press and public be excluded from the meeting for the following item of business on the grounds that it may involve the likely disclosure of exempt information as defined in Paragraph 1 of Part I of Schedule 7A to the Act".

CONSIDERATION OF APPOINTMENT OF CHIEF EXECUTIVE/HEAD OF PAID SERVICES

There was submitted report dated 12th April, 1995 by the Interim Clerk (previously circulated) in connection therewith.

Following consideration, the Council unanimously agreed as follows:-

1. That the Interim Clerk should open the sealed envelopes containing the applications.
2. To instruct the Interim Clerk to circulate a copy of the applications to each member of the Council, together with a synopsis.
3. To adjourn the Council meeting to 4 p.m. on Wednesday, 3rd May, 1995 at which time the Council would draw up a short leet and fix a date for interviews.

The Council agreed that any amendments to the Standing Orders be considered at the adjourned meeting of the Council.
