NOTES

1. The tender was advertised on Public Contracts Scotland to establish a list of suitably qualified contractors. 28 notes of interest were recorded of which 7 submitted a completed Pre-Qualification Questionnaire. A tender list of 3 contractors was drawn up from the 7 submissions.
2. Both tenders have been checked arithmetically and represent good value by current pricing levels; adjustments have been made where appropriate in accordance with the code of tendering procedures. It should be noted that the project was tendered on the basis of a schedule of rates. The reported amounts are notional values only based on provisional sums
3. The following contractors were invited to tender but failed to submit an offer:-

4. The date of lodgement of tenders was 20th October 2010
5. The date of expiry of tenders is 19th January 2011
6. The Head of Finance (Dept. of Corporate Services) has been consulted in accordance with financial regulations.
7. The notional tender project cost of £62,950.00 can be funded from the HRA Capital Budget. It is anticipated that actual expenditure will exceed that of the notional tender amount.
8. A Pre-Construction Information Pack relating to the CDM Regulations was not required for this project.
9. The Chief Executive Officer and the Executive Director of Housing, Environmental and Economic Development are in agreement with this report.

It is recommended that the Tender of Allander Roofing be selected as the lowest Tender for the Authority and be approved by the Members of the Tendering Committee.
