Subject: Application for renewal of Taxi/Private Hire Car Driver's Licence

1. Purpose

- 1.1** To consider an application for renewal of a Taxi /Private Hire Car Driver's Licence submitted by Mr. James Murray, 348 Halley Street, Yoker, Glasgow, G13.

- 3.1** Mr. Murray submitted an application for renewal of a Taxi /Private Hire Car Driver's Licence to the Council on 20 April 2012.
