## LEASE OF EAST END FOOTBALL PITCH, GLASGOW ROAD, DUMBARTON G82 1RH

A report was submitted by Chief Officer – Resources seeking approval to transfer East End Football Pitch and associated Pavilion, Glasgow Road, Dumbarton G82 1RH to St Patrick's Former Pupils.

Chair invited John Demspter to address the Committee. Mr Dexter was heard and requested that the Committee delay any decision regarding the lease of East End football pitch, until all users had been consulted.

After discussion and having heard the Asset Co-ordinator in further explanation and in answer to Members' questions, the Committee agreed:-

- (1) to approve the lease of East End Football Pitch and associated Pavilion for a period of ten years to St Patrick's Former Pupils;
- (2) that there is an engagement exercise with the current users and St. Patrick's Former Pupils, facilitated by Officers, to understand all concerns and reach an agreement, going forward, on future usage, including face to face meetings with all three parties. If agreement is reached between them, Officers should proceed to conclude in consultation with the Convener. If agreement is not reached, no lease will be signed.
- (3) to authorise the Chief Officer Resources, to conclude negotiations; and
- (4) to authorise the Chief Officer Regulatory and Regeneration to conclude the transaction on such conditions as considered appropriate.

The Chair adjourned the meeting for a short recess. The meeting reconvened at 16.43 p.m. with the Elected Members listed in the sederunt present.

### LOCAL HEAT AND ENERGY EFFICIENCY STRATEGY (LHEES) CONSULTATIVE DRAFT

A report was submitted by Chief Officer – Regulatory and Regeneration, seeking approval for a draft Local Heat and Energy Efficiency Strategy (LHEES) 2024-2029.

After discussion and having heard the Economic Development Manager in further explanation and in answer to Members' questions, the Committee agreed:

- (1) to approve the draft Local Heat and Energy Efficiency Strategy 2024-2029 and delegate authority to the Chief Officer Regulatory and Regeneration to deliver against this plan;
- (2) to authorise commencement of public consultation of draft LHEES, following approval; and
- (3) to authorise development of Local Heat and Energy Efficiency Delivery Plan (LHEEDP) in line with the draft LHEES.

### NET ZERO COOPERATION AGREEMENT

A report was submitted by Chief Officer – Roads and Neighbourhood, seeking permission to enter a Net Zero Cooperation Agreement developed between West Dunbartonshire Council and Glasgow City Council. The Agreement proposes to share expertise, skills, resources and infrastructure to help deliver the Council's Climate Change Action Plans to deliver Net Zero ambitions.

After discussion and having heard the Chief Officer – Roads and Neighbourhood Services in further explanation and in answer to Members' questions, the Committee agreed:-

- (1) to approve the proposal to enter into the Net Zero Cooperation Agreement with Glasgow City Council;
- (2) to note that the agreement would be governed through the establishment of a Project Board;
- (3) to note that updates would be provided to committee within the Climate Change Action Plan annual monitoring report; and
- (4) to authorise the Chief Officer Regulatory and Regeneration to enter the Net Zero Cooperation Agreement on such conditions as considered appropriate.

# LEASE OF WEST DUNBARTONSHIRE ACTIVITY CENTRE 73 ARDOCH CRESCENT, BRUCEHILL, DUMBARTON G82 4EN

A report was submitted by Chief Officer – Resources seeking approval of the lease of West Dunbartonshire Activity Centre to West Dunbartonshire Gymnastics Club.
