Learning Points

What are the positives to be shared?

Generally a good and interesting read. Well presented, showcasing lots of interesting projects and initiatives which is impressive for a small authority. Putting in the service structure at the beginning is helpful and the use of testimonies from stakeholders is good.

Suggestions for strengthening the next PPF?

- Perhaps a little long (65 pages compared to our 38)
- The narrative appears to be a series of case studies which are presented without much overall context. The case studies aren't in the format recommended by the guidance, and maybe some of them could have been a little more concise (or omitted see below)
- The Design and Place Panel looks interesting, but I would have been keen to see a case study demonstrating the difference that the panel had made to a project.
- The Dumbarton TC Conservation Area Designation doesn't actually seem to have actually kicked off yet. Maybe an example of a project that should have been held back to subsequent years. Similar comment for Rediscovering the Antonine Wall (which we are also involved in).
- Their participation numbers in the MIR consultation seem modest, particularly as these took place in conjunction with community planning. I would have looked for a bit more evidence of innovation in their consultation and attempts to reach wider audiences e.g. through social media.
- The inclusion of the Dumbarton Football Stadium project as a case study seemed a bit odd, as the outcome of the pre-application process was an application that was fundamentally at odds with policy. Not sure what this was meant to demonstrate!
