TYPES OF VEHICLE OPERATING AS TAXIS WITHIN THE CLYDEBANK ZONE

With reference to the Minutes of the Meeting of the Licensing Committee held on 1 June 2010 (Page 2930 refers), a report was submitted by the Head of Legal, Administrative and Regulatory Services advising of a representation submitted by a Clydebank taxi operator, Mr. Andrew Barclay, asking the Committee to consider allowing taxis operating within the Clydebank zone of West Dunbartonshire to be extended to allow saloon cars.

After hearing the Principal Solicitor, it was noted that Mr. Barclay and a representative from the Clydebank Taxi Trade Association had been invited to attend the meeting.

After hearing the Principal Solicitor in further explanation of the report, it was noted that the Committee would not be asked to make a decision on the proposed taxi stance at this meeting but was asked to authorise officers to proceed with a consultation on the proposal, the outcome of which would be reported back to the Committee for determination.

After hearing Councillor J. McColl in further explanation of the decision of the Planning Committee on 3 August 2010 (Pages 2988 - 2989 refer) and Mr Walsh, Engineer (Traffic) in answer to a Member's question, the Committee agreed:-

- (1) that officers be authorised to consult the taxi trade regarding the proposed appointment and revocation of the taxi stances;
- (2) that officers be authorised to make the necessary arrangements to give notice of the proposed appointment and revocation of the taxi stances to the Chief Constable and public notice of the proposals;
- (3) to note that if representations or objections to the proposals were received, the representations or objections would require to be considered by the Committee; and
- (4) that, if possible, the public notice referred to at (2) above should contain a map which illustrates the location of the proposed taxi stance.
