### RELOCATION OF ADULT INPATIENT PSYCHIATRIC CARE FROM CHRISTIE WARD TO GARTNAVEL ROYAL HOSPITAL/VALE VISION

A report was submitted by the Partnership Director:-

- (a) formally reporting that the Cabinet Secretary for Health, Wellbeing and Cities Strategy had agreed to approve the proposal by the NHS Board to permanently transfer inpatient adult beds from the Christie Ward at the Vale of Leven Hospital to Gartnavel Royal Hospital;
- (b) advising that the Vale Monitoring Group had now been dissolved; and
- (c) setting out the roles of the CHCP Committee and the CHCP Public Partnership Forum in the ongoing monitoring of the new arrangements as required by the Cabinet Secretary.

Following discussion and having heard the Partnership Director in further explanation of the report and in answer to questions from Members', the Partnership agreed:-

- (1) to re-affirm its support and commitment to the work of CHCP community-based mental health services and mental health activity undertaken by CHCP staff and services more generally and their on-going development;

- (1) to note that any ongoing or completed work would continue to ensure that the grades awarded to residential and day care services would be increased to the quality levels expected by the Council;
- (2) that a progress report on the four care homes who received critical reports from the Care Inspectorate and also covering all care homes directly managed by West Dunbartonshire Council, would be submitted to the next meeting of the Partnership;
- (3) that the report detailed at item (2) above would include financial implications for the Council in addressing any requirements to ensure the premises and facilities are maintained in a good state of repair internally and externally; and
- (4) otherwise to note the contents of the report.

#### APPROVAL OF NEW HEALTH AND CARE CENTRE FOR VALE OF LEVEN

A report was submitted by the Partnership Director advising of the Scottish Government's formal approval of the Full Business Case for a new Health & Care Centre on the Vale of Leven Hospital site.

Following discussion and having heard the Partnership Director in further explanation of the report, the Partnership agreed:-

- (1) to express its appreciation to the CHCP staff and other partners for securing this important capital development for the local area in anticipation of the imminent commencement of construction and the scheduled opening of this leading-edge facility in Summer 2013; and
- (2) to note that this new facility would be named/referred to as The Vale Centre for Health and Care.

### SCHEDULED CARE INSPECTION OF WEST DUNBARTONSHIRE COMMUNITY HEALTH AND CARE PARTNERSHIP
