

SUPPORTING PEOPLE CLIENT STATISTICS 2004-05

1. Introduction

- 1.1 This bulletin presents key statistics on <u>clients</u> assisted through Supporting People funding during the period 2004-05. Summary information has been provided at both national and local authority level. This is the second year for which data have been collected and it is intended to review the content for future bulletins.
- 1.2 Please exercise caution when comparing 2003-04 data with 2004-05 data as some element of change may be due to improved collection methods. However, there will be some degree of client change, as new services funded from 'SP Pipeline funding' came on stream in 2004-05 and some services started in 2003-04 have reached full capacity in 2004-05.



Note: Glasgow data are estimates based on a return of 77% boosted up to 100%. Glasgow data are snapshot as at 31 March 2005 and cannot be directly compared to 2003-04 data which is annual. 2004-05 data for Fife cannot be directly compared with 2003-04 data which was based on number of places and therefore an undercount. Renfrewshire data are snapshot as at 31 March 2004 and 31 March 2005.

2. MAIN POINTS

- 2.1 In 2004-05, 170,584 individuals were assisted through Supporting People funding. This represents 4% of the population aged 16 and over. The local authorities with the highest percentage of clients per head of population aged 16 and over were West Dunbartonshire (12%), Renfrewshire (9%) and Angus (7%). The lowest percentages were found to be in Eilean Siar, Orkney and Shetland (all at 1%) (Table 1).
- 2.2 The biggest groups of clients who received support were older people (49%), homeless or rough sleepers (16%) and other vulnerable groups (15%) (Table 2). Older people are the majority group for 23 local authorities and homeless people for a further five local authorities (Table 8).
- 2.3 Females made up 58% of clients and the people aged 26-49 and 75-84 constituted the largest groups (both at 22%) with 52% of clients being 65 or over (Table 9).
- 2.4 The largest providers of support were local authority housing (28%), registered social landlords (26%) and local authority social work departments (25%). Voluntary organisations provided 17% of support (Tables 5 and 11).
- 2.5 Accommodation linked continuous support was received by 37% of clients and one to four hours floating support, received by 33% (Tables 4 and 12).
- 2.6 Of all clients, 52% received permanent support and 16% received short stay support (Tables 6 and 13).
- 2.7 Nearly half of all clients received support in mainstream housing (45%), with a further 33% in special housing (Tables 7 and 14).

3. BACKGROUND

Supporting People is a new integrated policy and funding framework for housing support services introduced from April 2003. The aim is to provide good quality services focused on the needs of users, to enable vulnerable people to live independently in the community, in all types of accommodation and tenure.

Housing support services have grown up over a number of years, often in a fairly ad-hoc way in response to the needs of individuals or of the tenants of a particular landlord. The Supporting People programme aims to put these services on a secure legal footing, with a systematic and strategic process to assess needs and supply of support services in local areas and make provision accordingly.

Previously, housing support services were funded from a number of sources, including Housing Benefit (the Transitional Housing Benefit Scheme), Special Needs Allowance Package (SNAP) and Resettlement Grant. On 1 April 2003, these resources were transferred to local authorities, who are now responsible for the new arrangements. Local authorities and their partners, including health agencies, service providers and service user groups, will assess the overall levels of need in their area and commission appropriate services to meet those needs, funding them on a contract basis. Strategic planning for Supporting People is linked to the Local Housing Strategy and other local plans for community care, health improvement, social inclusion etc. Services will also, for the first time, be subject to quality monitoring, through registration by the Scottish Commission for the Regulation of Care, and contract compliance procedures.

4. NOTES ON TABLES

- 4.1 The data presented in these tables refer to financial years 2003-04 and 2004-05 with the exception of Renfrewshire council who were only able to provide snapshot figures at 31 March each year.
- 4.2 Particular care should be taken when comparing the two years data for Fife and Glasgow. 2003-04 data for Fife council was based on the number of places and therefore an undercount of the actual number of clients, and 2004-05 data is client based. Glasgow City council produced financial year data for 2003-04 but for 2004-05, were only able to produce snapshot data as at 31 March 2005. For both local authorities, the two years data cannot be directly compared.
- 4.3 This is the second collection of such data and as a result, some local authorities have had difficulty in providing all of the information requested. Where this occurs, estimates have been made and these have been detailed in the footnotes.
- 4.4 Please exercise caution when comparing the two years data, as some element of change may be due to improved collection methods. However, there will be some degree of client change as new services funded from 'SP Pipeline funding' came on stream in 2004-05 and some services started in 2003-04 have reached full capacity in 2004-05.
- 4.5 A client may be recorded in more than one client group, support hours, duration of support or support provider if their needs change during the course of the year, however the client should only be counted once in the net totals. Some local authorities have been unable to remove this double counting and where this occurs, gross totals have been reduced proportionally to total the net number of clients.

5. NOTES AND DEFINITIONS

- 5.1 Statistics on clients receiving housing support through supporting people are collected by local authority returns submitted to the Scottish Executive. 2003-04 was the first year of this collection and the same return was used again to collect the data for clients supported during 2004-05.
- 5.2 Additional tables may be obtained from Housing Statistics on request. See back cover for contact details. Housing statistics publications, including printable Adobe portable format and Excel versions of tables are available in the published data section of the Housing Statistics reference website: www.scotland.gov.uk/stats/housing/hsbref.

5.3 Definitions used in tables

Duration of support:

- Permanent: Services are provided on an indefinite basis as part of the overall objective of the support plan.
- Medium stay: Services are provided for more than two years and there is an expectation that the provision will end in accordance with the objectives of the support plan.
- Short stay: Services are provided for less than two years and there is an expectation that the provision will end in accordance with the objectives of the support plan.
- Up to one month: Services are provided for a limited period of one month in accordance with the objectives of the support plan.
- Variable: The service will vary depending upon the assessed needs of the person and in accordance with the objectives of the support plan.
- Unspecified: The period of support is not known.

Accommodation type:

- Homeless: A person without accommodation which he or she is able to occupy legally or without risk of violence or, if overcrowded, without danger to health.
- Mainstream housing: The accommodation occupied by the person is not specifically provided in response to assessed social or medical care needs. Mainstream Housing includes moveable homes.
- Special housing: Housing with specific physical features to facilitate use by people with disabilities.
- Sheltered Housing: Sheltered Housing is a form of Housing with Support; however it is sufficiently distinguished from other supported accommodation to merit a separate category.
- Supported accommodation: Accommodation with staff support available.

Accommodation linked support:

• Support services specifically linked to identified accommodation.

Floating support:

• Support services provided to an individual irrespective of location, tenure or accommodation type.
