Note 1 Carers Allowance - Underlying Entitlement

An award of £0.00 made, due to the person being in receipt of a benefit which cannot be paid at the same time as CA (e.g. state pension, incapacity benefit), known as overlapping benefit rules. Entitlement to the Carer's Premium will mean an increase in income related benefits such as Housing/Council Tax benefit and/or Income Support, and/or Pension Credit and this is reflected in the financial gains for the relevant benefit.
