MINUTES OF PREVIOUS MEETING

10778 The Minutes of Meeting of the Committee held on 15 November 2006 were submitted and approved as a correct record.

AWARDING OF CONTRACT FOR KNOXLAND PRIMARY SCHOOL, DUMBARTON - REFURBISHMENT

10779 A report was submitted by the Acting Director of Housing, Regeneration and Environmental Services (Housing & Regeneration Services) advising of the award of the above contract under delegated authority.

10780 The Committee agreed to note the awarding of the contract to Alexander Arthur & Sons Ltd., Clydebank in the amount of £654,233.27.

AWARDING OF CONTRACT FOR CARRIAGEWAY PATCHING - CLYDEBANK

10781 A report was submitted by the Acting Director of Housing, Regeneration and Environmental Services (Land & Environmental Services) advising of tenders received for carriageway patching, Clydebank and recommending acceptance of the most economically advantageous tender.

- 10782 Having heard the Manager of Roads in answer to Members' questions, the Committee agreed to approve the awarding of the contract to Tough Construction Ltd. in the amount of £63,015.35 as the most economically advantageous tender.

**AWARDING OF CONTRACT FOR INSTALLATION OF PUBLIC
LIGHTING – McCOLL AVENUE, ALEXANDRIA**

- 10783 A report was submitted by the Acting Director of Housing, Regeneration and Environmental Services (Land & Environmental Services) advising of tenders received for the installation of public lighting for McColl Avenue, Alexandria and recommending acceptance of the most economically advantageous tender.
- 10784 After discussion and having heard the Manager of Roads in answer to Members' questions, the Committee agreed to approve the awarding of the contract to Centre Great 1991 Ltd. in the amount of £62,658.65 as the most economically advantageous tender.
- 10785 In relation to a point raised by Councillor Agnew concerning light pollution and the technical design of lighting columns, it was noted that a report on this subject would be submitted to a future meeting of the appropriate Committee.
