**WEST DUNBARTONSHIRE COUNCIL****Licensing Standards Officers report on an occasional licence application provided under Section 57(3) of the Licensing (Scotland) Act 2005: 10 July 2014**

**Applicant:** Senex Investments Limited, 4 Lynedoch Crescent, Glasgow G36 6EQ

**Premises Licence Number:** WDLBPREM/0268 Casa Italia

**Summary of the application:-**

Friday 18 July 2014 to Tuesday 30 September 2014 inclusive. 1100 hours to 2200 hours for the sale and consumption of on sales alcohol, ancillary to food, with full children's access.

The application refers to 1 external area of 4 tables of four at Casa Italia, Montrose Street, Clydebank where the description of activities is, *Al fresco dining for customers of Casa Italia at outdoor tables in the context of "Casa Italia Al Fresco Dining Summer 2014." event. Any alcohol consumed will be ancillary to meals.*

**Officer comments:**

The officer would refer the Board to the following paragraph from the Licensing Policy;

"20.1.1 Occasional Licences and the number that can be applied for by any one premises"

*The Board recognises the terms of the Licensing (Scotland) Act 2005 which, allows repeated applications for occasional licenses and no restriction on the numbers of occasional licences that can be applied for except where the applicant is a voluntary organisation. However, the Board is concerned that some premises may seek to avoid the requirements of the Act by applying for repeated applications. Accordingly, the Board may require in respect of repeated applications from the same premises to be addressed by the applicant as to why an application for an occasional licence is appropriate rather than an application for a premises licence."*

The applications cover an extensive period and it may be that an application for a variation to the Premises Licence would be the appropriate method to change the operation of the premises. To this end I believe that paragraph 20.1.1 of the Licensing Policy has relevance and should be considered by the Board. Officers are aware that the area applied for does not have the appropriate planning permission and on that basis its' longer term use would render it currently unsuitable for the sale of alcohol.

Longer term use of an outside area via occasional licences may be seen as an attempt to circumvent the conditions placed on the Premise Licence that these applications are connected to.

These premises have been compliant with all the requirements of the Licensing (Scotland) Act 2005.

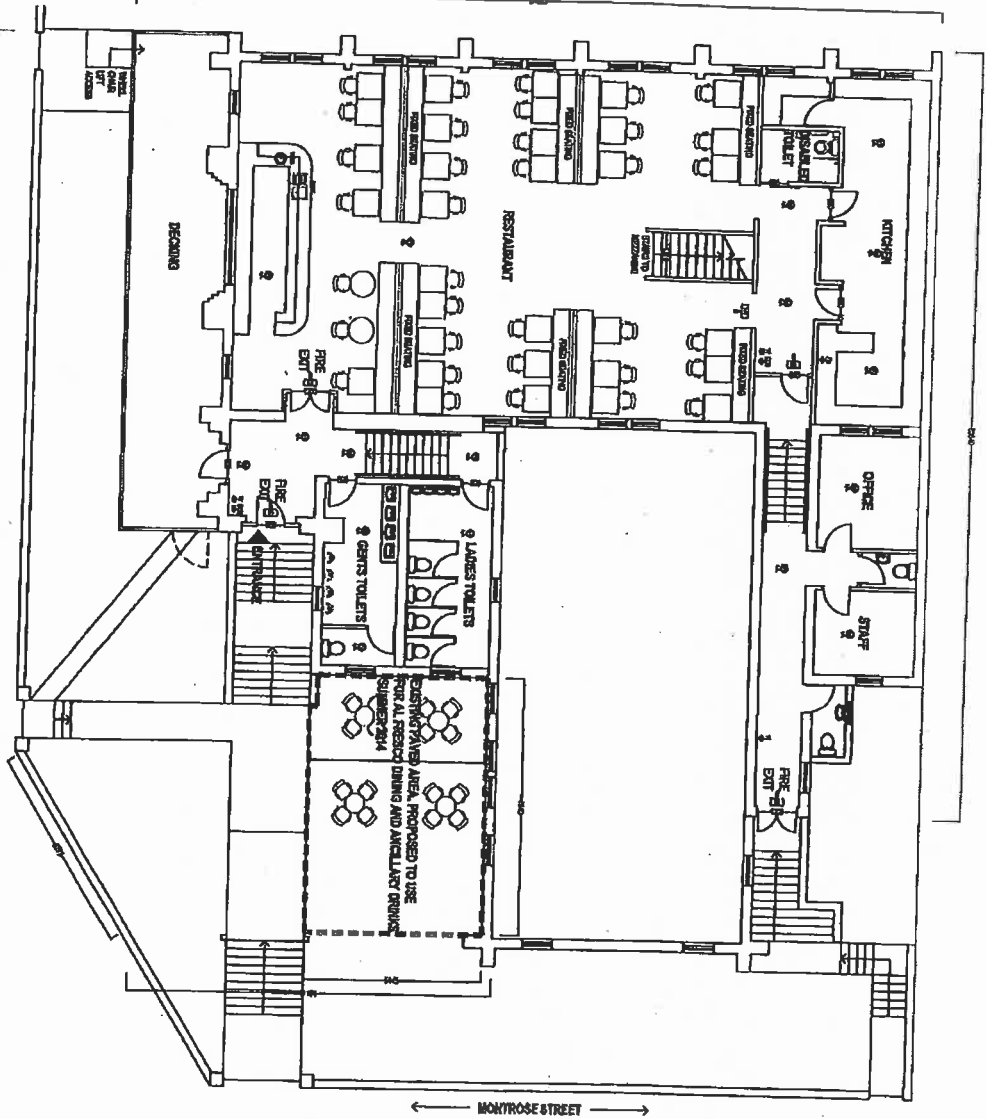
