#### STATEMENT BY CHAIR

Councillor Finn, Chair, welcomed all those present to the meeting which was being held virtually. He noted the meeting would be recorded and streamed live but would not be available for future playback.

#### MINUTES OF PREVIOUS MEETINGS

The Minutes of Meeting of the Licensing Committee held on 2 February 2022 (ordinary), 16 March 2022 (special) and 30 March 2022 (special) were submitted and approved as correct records.

#### TAXI FARE REVIEW - CLYDEBANK ZONE

A report was submitted by the Chief Officer – Regulatory and Regeneration providing an update on the review of fares and charges applicable to taxis operating within the Clydebank Taxi Licensing Zone.

#### **DECIDED:-**

Having heard the Section Head – Litigation and Senior Officer (Licensing Services) in further explanation of the report, and in answer to Members' questions, the Committee agreed:-

(1) that the current level of fares and charges applicable to the Clydebank Taxi Licensing Zone be amended as follows:-

increase the flagfall on all tariffs by 30p; increase the running mile by 10p on all tariffs; alter the wording under Tariff 3 to read:- (between 9.00pm and 6.00am a 50p extra charge applies) increase maximum soiling fee from £60 to £100;

- (2) that officers arrange for the advertisement of the fares and charges agreed by the Committee; and
- (3) that authority be delegated to the Chief Officer Regulatory and Regeneration, in consultation with the Chair of the Licensing Committee, to conclude the review without the requirement for the Committee to consider a further report on the matter provided no objections or representations are received in relation to the proposal.

Notice of Proposal to hold a Public Procession: Dumbarton Orange & Purple District No. 27

#### 1. Purpose

1.1 The purpose of this report is to assist the Committee in considering whether to depart from the code of conduct which prohibits the playing of music before 9.00 am, to allow the playing of music at 8.30 am as requested by the Dumbarton Orange & Purple District No. 27 within their notification.

#### 2. Recommendations

2.1 It is recommended that Members consider the request from Mr. Simon Wade to allow the accompanying band, The Pride of the Rock Flute Band, to play music at 8.30 am as the Dumbarton Orange & Purple District No. 27 procession passes through Alexandria on the morning of Saturday 2 July 2022.

#### 3. Background

- 3.1 The notice of proposal to hold a public procession and risk assessment was submitted by Mr. Simon Wade on behalf of the Dumbarton Orange & Purple District No. 27 on 13 April 2022. The reason for the procession, stated on the notice of proposal, is for the Annual Boyne Celebration. The notice of proposal was subsequently advertised on the Council's website on 13 April 2022.
- 3.2 A similar application was brought before the Licensing Committee in 2018 where Members decided to grant the request from Dumbarton Orange & Purple District No. 27 to allow the playing of music from 8.30 am.
- 3.3 A precursory meeting was held on 12 May 2022 with the organiser and Police Scotland. Discussions involved the request to deviate from the Council's code of conduct were raised and the requirement for no play zones at certain points of the routes.

#### 4. Main Issues

**4.1** The Council's code of conduct states:-

'Unless specifically stipulated in the notification, no band shall play or music shall be played before 9.00 am and after 9.00 pm.'

- **4.2** The purpose of the restriction on times when music should not be played is to minimise disruption to local communities.
- 4.3 An email dated 14 April 2022 was received from Councillor Bollan objecting to the request to play music prior to 9.00 am (Appendix 1).
- 5. People Implications

- 7. Risk Analysis
- 7.1 The Committee, in considering whether or not to depart from the code of conduct by allowing music to be played at 8.30 am should consider the risk of disruption to the community.

- **9.4** Police Scotland were sent a copy of the Notice of Proposal on 13 May 2022.

- 3.1 Mr. Winters submitted an application for renewal of a Taxi/Private Hire Car Driver's Licence to the Council on 24 February 2022.
- 3.2 A letter was received from the Chief Constable of the Police authority on 15 March 2022 submitting an objection in connection with the application.
- 3.3 Mr. Winters' current Taxi/Private Hire Car Driver's Licence has an expiry date of 13 March 2022.
- 3.4 At a meeting of the Licensing Committee held on 18 August 2021, Mr. Winters was the subject of hearing regarding the possible suspension or revocation of a Taxi/Private Hire Car Driver's Licence having received a request from the Chief Constable of Police Scotland. Following consideration, the Committee agreed that the alleged misconduct had not at that time been established, and pending court dates and the outcome, it would be brought back to the Committee if misconduct was established.
- 3.5 At the meeting on 27 April 2022 it was agreed that consideration of the application be continued to the next meeting of the Committee once further information was available.
- 3.6 The representative from the Police will be able to provide an update on the outcome of the court proceedings and the resultant sentence issued.

#### 1. Purpose

1.1 To consider an application for grant of a Taxi/Private Hire Car Driver's Licence submitted by Mr. Stephen Eaton, 18 Smollett Street, Alexandria G83 0DS.

#### 2. Recommendations

**2.1** It is recommended that the application be considered and determined by the Committee.

#### 3. Background

- 3.1 Mr. Eaton submitted an application for grant of a Taxi/Private Hire Car Driver's Licence to the Council on 16 March 2022.
- A letter was received from the Chief Constable of the Police authority on 12 April 2022 advising that the Police were unable to submit a comment on the application at this point in time due to matters which required further investigation.
- 3.3 Further letters were then received from the Chief Constable of the Police authority on 18 May 2022 submitting an objection to the application detailing a number of convictions deemed as 'protected' under the Rehabilitation of Offenders Act 1974.
- 3.4 In terms of the relevant legislation, an objection with respect to an application should be submitted within 28 days of receipt of the application. As Mr. Eatons' application was received on 16 March 2022, any objection should have been submitted by 13 April 2022. There is, however, provision in the legislation for the Licensing Authority to entertain a late representation which has been received before a final decision has been made if the Licensing Authority is satisfied that there is sufficient reason why the objection had not been submitted in the time required.

#### 4. Main Issues

- 4.1 In view of the submission received from the Police, the applicant and a representative of the Police authority have been invited to attend the meeting of the Committee to be held on 8 June 2022.
- **4.2** If the Committee decide to entertain the late objection, it will be a matter for the

Committee to decide whether the applicant's protected convictions should be disclosed and taken into consideration. It should be noted that protected convictions cannot be considered unless there is no other way of doing justice.

**4.3** The terms of the letters from the Police will be made known to the Committee at the meeting as appropriate.
