# LICENSING OF HOUSES IN MULTIPLE OCCUPATION (HMO) – CHANGES TO LEGISLATION AND GUIDANCE

A report was submitted by the Head of Legal, Democratic and Regulatory Services:-

- (a) providing information on the new legislative provisions and statutory guidance relating to Houses in Multiple Occupation (HMO) licensing; and
- (b) seeking approval of the new licence conditions and implementation dates where applicable.

- (1) to approve the new licence conditions as detailed at Appendix 1 to the report;
- (2) to approve an implementation date of 1 April 2012 for all local HMOs to meet the statutory safety related provisions as explained in Section 3.15 of the report;
- (3) to approve the implementation date of non safety related provisions for existing HMOs as being the date of application for a new licence or expiry of the existing licence, whichever is sooner; and

(4) to approve no change to the existing licence fee but a fee of £128.96 for the processing of a new licence where a material change in an existing licence required a new licence.
