MINUTES OF PREVIOUS MEETING

The Minutes of Meetings of the Licensing Committee held on 14 June 2023 were submitted and approved as a correct record.

OPEN FORUM

The Committee noted that no open forum questions had been submitted by members of the public.

REQUIREMENT FOR A CRIMINAL RECORD CHECK

A report was submitted by the Chief Officer – Regulatory and Regeneration to allow Members to consider whether to dispense with the requirement for a criminal record check from an applicant's country of origin.

Having heard from Michael McDougall, Section Head – Licensing and in answer to Members' questions, Members agreed to dispense with the requirement for a criminal record check for this applicant and requested that Officers review the Licensing Committee's policy in respect of requiring a criminal record check from any future applicant's country of origin.

DECIDED:-

HEARING REGARDING POSSIBLE SUSPENSION OR REVOCATION OF A LATE HOURS CATERING LICENCE - CONTINUATION

A report was submitted by the Chief Officer – Regulatory and Regeneration in relation to a matter continued from the meeting on 14 June 2023 asking Members to consider a request from the Chief Constable of Police Scotland for the suspension of a Late Hours Catering Licence held by Mr. Shafiqullah Khalil for the premises, Aladdin Hot For You located at 6 High Street, Dumbarton, G82 1LL. Members were advised they also had the option to revoke the licence.

Having heard from Michael McDougall, Section Head – Licensing and in answer to Members' questions, the Committee then heard from Mr Campbell, Solicitor and Legal Representative for Licence holder Mr Shafiqullah Khalil. Mr Campbell advised Mr Shafiqullah Khalil was currently out of the country and looking after his mother who was not well. Mr Campbell asked for a continuation of the hearing to the next meeting of the Licensing Committee so Mr Shafiqullah Khalil could attend in person and respond to the concerns raised by Police Scotland. Mr Campbell provided Members with vouching in relation to the continuation request.

ADJOURNMENT

Subject: Hearing regarding possible suspension or revocation of a Late Hours Catering Licence

1. Purpose

1.1 To consider a request from the Chief Constable of Police Scotland for the suspension of a Late Hours Catering Licence held by Mr. Shafiqullah Khalil for the premises, Aladdin Hot For You located at 6 High Street, Dumbarton G82 1LL. Members also have the option to revoke the licence.

2. Recommendations

2.1 The Committee are asked to consider the terms of this report, the terms of the letter from the Chief Constable and any evidence presented at the hearing and thereafter determine whether the licence should be suspended and, if so, the duration of the suspension and date of commencement thereof or alternatively revoke the licence.

3. Background

- 3.1 On 17 May 2023, a letter was received from the Chief Constable of Police Scotland requesting the immediate suspension of the Late Hours Catering Licence held by Mr. Khalil under Paragraph 12(1) of Schedule 1 to the Civic Government (Scotland) Act 1982 on the grounds that the carrying on of the activity to which the licence relates is likely to cause a serious threat to public safety.
- 3.2 Having consulted with the Chief Officer, Regulatory and Regeneration, it was decided that the Late Hours Catering Licence held by Mr. Khalil did not merit an immediate suspension under Paragraph 12 of Schedule 1 to the Act.
- Mr. Khalil previously held a Late Hours Catering Licence for the premises having been granted the licence at Committee on 20 February 2019. The licence expired on 19 February 2022 and no renewal application was submitted at that time.
- 3.4 Mr. Khalil's current Late Hours Catering Licence has an expiry date of 23 June 2025 having had the licence granted on 24 June 2022 The operating hours of the Late Hours Catering Licence are:-

Monday 11.00 pm to 1 am 11.00 pm to 1 am 11.00 pm to 1 am

Wednesday
Thursday
11.00 pm to 1 am
11.00 pm to 2 am
Friday
11.00 pm to 4.30 am
Saturday
11.00 pm to 4.30 am
11.00 pm to 2 am

- 3.5 At the Meeting of the Licensing Committee held on 14 June 2023, having heard from the legal representative of the licence holder, Members decided to continue consideration of the matter to the next Meeting of the Licensing Committee due to be held on 2 August 2023.
- 3.6 At the Meeting of the Licensing Committee held on 2 August 2023, having heard from the legal representative of the licence holder, Members decided to continue consideration of the matter again to the next Meeting of the Licensing Committee due to be held on 11 October 2023.

4. Main Issues

- 4.1 In his letter the Chief Constable also requested a suspension of the licence under Paragraph 11 of Schedule 1 to the 1982 Act. A licensing authority may, in these circumstances, order the suspension or revocation of a licence under Paragraph 11 if, in its opinion:-
 - (a) the holder of the licence is not, or is no longer, a fit and proper person to hold the licence and/or:
 - (b) the activity to which the licence relates is being managed by or carried on for the benefit of a person, other than the licence holder, who would have been refused the grant or renewal of the licence under paragraph 5(3) and/or:
 - (c) the carrying on of the activity to which the licence relates has caused, is causing or is likely to cause undue public nuisance or a threat to public order or public safety and/or;
 - (d) a condition of the licence has been contravened
- 4.2 The period of suspension of a licence is the unexpired portion of the duration of the licence, or such shorter period as the licensing authority may fix.
- 4.3 Where a licensing authority decides to order the suspension or revocation of a licence, the suspension or revocation generally does not take effect until the expiry of the time within which the holder of the licence may appeal against the suspension or revocation (28 days from the date of the decision to suspend) or, if an appeal has been lodged, until the appeal has been abandoned or determined in favour of the suspension or revocation. However, if the licensing authority determines that the circumstances of the case justify immediate suspension or revocation, it may order that the licence be suspended or revoked immediately.

- 4.4 A licensing authority must, before deciding to suspend or revoke a licence under Paragraph 11, give the holder of the licence and the Chief Constable an opportunity of being heard.
- 4.5 The licence holder and a representative of the Chief Constable have been invited to the meeting of the Committee on 11 October 2023 in order that a hearing may take place with regard to the possible suspension or revocation of the licence.
- 4.6 In considering whether to suspend or revoke a licence the licensing authority may have regard to any misconduct on the part of the licence holder which in the opinion of the authority has a bearing on his fitness to hold a licence.
- **4.7** The matters which the Committee will require to consider in relation to paragraph 4.1 above are as follows:-
 - (a) Whether the alleged misconduct has been established.
 - (b) If the Committee is satisfied that the alleged misconduct has been established, whether, having regard to the misconduct on the part of the licence holder, this has a bearing on Mr Khalil's fitness to hold a licence.
 - (c) If the Committee is of the opinion that Mr. Khalil is no longer a fit and proper person, or the activity to which the licence relates is being managed by or carried on for the benefit of a person, other than the licence holder, who would have been refused the grant or renewal of the licence under paragraph 5(3), or that the carrying on of the activity has caused, is causing or is likely to cause undue public nuisance or a threat to public order or public safety, the Committee must consider whether his licence should be suspended or revoked.
 - (d) If the Committee is of the opinion that a condition of the licence has been contravened then it may order the suspension or revocation of the licence.
 - (e) If the Committee is satisfied that the licence should be suspended, the Committee must give Mr. Khalil an opportunity of being heard on the length of the suspension and the date from which the suspension should commence.
 - (f) The Committee must then consider what length of suspension is appropriate and whether the circumstances of the case justify immediate suspension.
 - (g) If the Committee is satisfied that circumstances of the case justify revocation, the Committee must consider whether the circumstances of the case justify immediate suspension of the licence as well as revocation.

Subject: Civic Government (Scotland) Act 1982: Review of Taxi Fares and Charges -

Dumbarton and Vale of Leven Taxi Licensing Zone

1. **Purpose**

1.1 To report to the Committee on the review of fares and charges applicable to taxis operating within the Dumbarton & Vale of Leven Taxi Licensing Zone.

2. Recommendations

- 2.1 It is recommended that the Committee:-.
 - consider the fare structure submitted by the Dumbarton & Vale of Leven a) Taxi trade and the representation submitted by Mr. Kelly be considered along with the scales for taxi fares and related charges which were proposed by the representatives of the Dumbarton & Vale of Leven Taxi Trade and published in the 4 July 2023 edition of the Lennox Herald.
- 2.2 fixes the scales for taxi fares and related charges and authorise Officers to b) conclude the review by notifying each taxi operator of the new scales, their right to appeal to the Traffic Commissioner and, if there is no subsequent appeal against the scales, by giving public notice that the new scales are to come in to effect.

3. **Background**

- 3.1 In terms of the Civic Government (Scotland) Act, 1982, licensing authorities must fix scales for taxi fares and related charges within 18 months from the date on which the scales came into effect.
- 3.2 The fares and charges which are applicable to taxis operating within the Dumbarton & Vale of Leven Taxi Licensing Zone have been in effect since 26 May 2022 and these are detailed in Appendix 1.
- 3.3 The proposal submitted on 26 June 2023 by Mr. John Watters, Secretary of the Dumbarton & Vale of Leven Taxi trade, was detailed as follows:-

Flagfall

increase the flagfall on all tariffs by 30p;

Running Mile

increase the running mile by 20p on tariffs 1, 2 and 3; increase the running mile by 10p on tariff 4; increase the running mile by 30p on tariff 5 and increase the running mile by 50p on tariff 6.

Fares for waiting

Increase the fares for waiting from:-

10p for every 15 seconds (£24.00 per hour) to:-

10p for every 10 seconds (£36.00 per hour)

3.4 The fare chart advertised in the 4 July 2023 edition of the Lennox Herald is detailed within Appendix 2.

4. Main Issues

- 4.1 In terms of the relevant legislation and considering the contents of the Taxi and Private Hire Car Licensing Guidance 3rd edition recently updated in May 2023, before fixing any scales or carrying out any review, in addition to consulting with persons or organisations appearing to be representative of operators of taxis within the area, the Licensing Authority is required:
 - (a) to publish the proposed scales in a newspaper circulating in the area setting out the proposed scales, explaining the effect of the proposed scales and proposing a date on which the proposed scales are to come into effect;
 - (b) to invite representations from any persons with respect to the proposals within a period of one month from the date of publication of the notice; and
 - (c) to consider any such representations which have been duly lodged before a decision is taken on the matter.
- 4.2 Notice of the proposed scales appeared in the Lennox Herald on 4 July 2023 inviting representations from any persons with respect to the proposals to be received by 4 August 2023.
- 4.3 An email was received on 2 August 2023 from Mr Michael Kelly, a taxi operator within the Dumbarton & Vale of Leven taxi zone, making a representation in relation to the proposals. A copy of Mr. Kelly's representation is detailed within Appendix 3.
- 4.4 Mr Kelly was in agreement with all the proposals which were advertised with the exception of fares for waiting. Mr. Kelly proposed that the current rate for waiting time of 10p for every 15 seconds be retained.

Waiting Time

Retain the current rate of waiting time at £24.00 per hour.

Fares for Waiting

The Driver is, in addition to the above, entitled to charge for waiting whether in one stoppage or in several stoppages as follows:

For each period of FIFTEEN SECONDS or part thereof£0.10 (All Tariffs)

Soiling Fee

REVIEW OF TAXI FARES

NOTICE IS HEREBY GIVEN that West Dunbartonshire Council has reviewed the fares for the hire of taxis within the Dumbarton & Vale of Leven Zone of the local authority area and the outcome of the review is that there will be increases applied as follows:-

Initial flagfall (50p on Tariff 1, 2, 3, 4, 5 & 6)

Running mile (20p on Tariff 1, 20p on Tariff 2, 20p on Tariff 3, 10p on Tariff 4, 30p on Tariff 5 and 50p on Tariff 6)

Waiting time will increase from £24.00 per hour to £36.00 per hour
