## 14. NOTICE OF MOTION

In accordance with Standing Order No 8, Councillor McLaughlin has submitted the undernoted motion for consideration by Council:-

The A82 is the lifeline of this local community and is the main arterial roadway for a large number of travellers through this area. When work is carried out on the A82 the disruption caused is considerable, not just for the A82 but also the surrounding road infrastructure. For economic growth and for the health and wellbeing of our local community we must ensure that all disruption to the road is kept to a minimum. In addition serious consideration must be given about the upgrade of the road or alteration from the Renton to the Dumbarton roundabout.

Therefore this Council agrees to write to AMEY Highways and the Scottish Executive asking for:

- (a) Upgrading to be considered for the A82; and
- (b) That all routine maintenance and upgrading to the A82 should be carried out in the evening wherever possible.
