CHAIRPERSON'S REPORT

The Chairperson, Mr Paul Smith, provided an update on the business of the Forum for 2022/23. He welcomed the new Members of the West Dunbartonshire Licensing Board and thanked the outgoing Chair of the Licensing Board, Councillor Ian

Dickson, for his dedicated work and commitment to the Licensing Forum throughout his tenure. He noted that West Dunbartonshire Licensing Board and Licensing Forum had been pioneering in the work they had done throughout the Covid pandemic and endured what had been a particularly difficult time for the hospitality industry. He added that there were tough times ahead for the industry and its recovery would take some time.

He also commented on the additional pressures facing the industry, namely:-

- The cost of living crisis;
- The increase in costs of electricity and gas, particularly in a commercial sense having almost doubled making the running of hospitality establishments a costly business;
- The loss of client base for hospitality, with numbers of customers turning to the off-sales market rather than on-sales premises; and
- The cost of large debts that had been run up throughout the lockdown months.

MINUTES OF PREVIOUS MEETING

The Minutes of the Meeting of the Licensing Forum held on 8 March 2022 were submitted and approved as a correct record.

A REVIEW OF LICENSING RELATED ACTIVITY CARRIED OUT BY HEALTH THROUGHOUT 2021/22

Sylvia Chatfield, Head of Mental Health, Learning Disabilities and Addictions within West Dunbartonshire Health and Social Care Partnership, provided an overview of health activity during 2021/22 in relation to Licensing. She detailed the current Alcohol Harm Indicators which were used by Health when reviewing and responding to licensing applications and noted, in comparison to Scotland overall, West Dunbartonshire's stats were the worse.

Sylvia also updated the Forum on the current Planet Youth in Scotland survey which was completed by S3 pupils in Clydebank High School giving a better understanding of our young people and their access to and consumption of alcohol.

Sylvia lastly noted that West Dunbartonshire had some of the worst alcohol harm rates in Scotland and asked the Forum to note these findings and support measures to tackle the problem.

COVID-19 AND IMPACT ON LICENSING IN SCOTLAND UPDATE

Mr Smith, Chairperson, provided a verbal update on the impact of Covid-19 on Licensing in Scotland. He advised that we are beginning to now see the data on the significant shift of consumption of alcohol from the On-Sales trade premises to Off-Sales which was understandable when the hospitality industry was

effectively closed but had now re-opened, showing that customers were still slow in returning.

He advised that it was worth noting that the cost of production of alcohol, including the cost of ingredients, had sky-rocketed in recent months since the pandemic had eased, which would inevitably increase the on-trade price of alcohol. He further advised that only the large supermarkets would be better equipped to absorb the additional costs effectively and this could really effect the smaller on-trade and off-sales licensed premises.

Lastly, Mr Smith advised that one of the key duties of the Licensing Board was to produce an Overprovision Policy. The existing Policy would have to be refreshed and all of partner agencies who inputted significantly to the existing Policy would be required to liaise and update their contribution to the new Policy. He asked Lawrence Knighton, Licensing Standards Officer for West Dunbartonshire Council to research what was required and also the deadline date for the new Overprovision Policy and circulate this information to Forum members.

LICENSING STANDARDS OFFICER'S - UPDATE

Lawrence Knighton, Licensing Standards Officer, West Dunbartonshire Council provided a verbal update on issues and events that may be of interest to the Forum. He noted that Pub watches had been successfully re-established since the pandemic which was good news for the trade. He advised that they were noticing a certain amount of normality returning to the trade such as larger events taking place, e.g. the Kiltwalk and Pipe Band Championships etc. Equally there was an increased amount of interest in smaller community events and West Dunbartonshire had received 245 occasional license applications this year so far and the average prepandemic was 300 for the full year so it appeared things were back on track to where they were prior to the pandemic.

Mr Knighton also noted that there was an ongoing project to reduce trouble in local green space and parks etc. in conjunction with Police Scotland aimed at making outdoor spaces safer.

He also asked for assistance from the Forum on the use of Occasional Licenses for outdoor beer gardens on Licensed Premises. The regulations for Occasional Licenses being granted were relaxed during the pandemic to make socialising and social distancing easier, however this relaxing of the rules will cease in September 2022 and there was concern that the Scottish Government may then request the applicant to seek Planning permission for the outdoor space, so Forum members will need to liaise closely to decide if Occasional Licenses going forward will continue to be the norm or if it would be for Planning to make the final decision. The Licensing Board will require to work closely to ensure correct decisions are made on applications; particularly when there has been very little trouble, if any at all, driven from these outdoor spaces and they have been of great assistance to the trade.

UPDATE FROM POLICE SCOTLAND

The Licensing Sergeant, Sergeant David Holmes, Police Scotland, introduced himself to the Forum as this was his first meeting and stated that he was looking forward to working closely with Members of the Forum. He advised, from a Police perspective, that they were beginning to see a return to normal in terms of post-pandemic and the public slowly returning to on-sales premises.

He noted that since he had been appointed to the Licensing Sergeant role there had not been anything glaring or urgent requiring to be dealt with in terms of License trade in West Dunbartonshire. Any incidents which had been raised he had noted that Police Scotland had worked well with the LSOs and License holders to offer additional support and be more pro-active in the area to ensure it did not happen again. Sergeant Holmes advised that he would liaise with LSOs and the Interim Depute Clerk in the coming months and discuss anything he could bring back to the next Licensing Forum meeting.
