VARIATION OF ORDER OF BUSINESS

JOINT IMPROVEMENT TEAM

A report was submitted by the Acting Director of Social Work Services advising that the Joint Improvement Team (JIT) would be attending the meeting, in order to inform on the work that the JIT had undertaken.

- ⁷⁵⁶¹ Following a question and answer session, the Partnership agreed to note the contents of the report and the discussion that had taken place in respect of this matter.
- Thereafter, the Convener, Councillor Rooney, thanked Mr Martin and Ms Torrance for their interesting and informative presentation.

MINUTES OF PREVIOUS MEETINGS

- (a) The Minutes of Meeting of the Partnership held on 24 August 2005 were submitted and approved as a correct record, subject as undernoted:-
- ⁷⁵⁶³ In relation to a point raised by Councillor McLaughlin concerning the item entitled "Leven Cottage" (Page 1825, paragraph 6664 refers), it was agreed that the minute be amended to record that the terms of the motion which had been moved by Councillor McLaughlin and seconded by the Rev. Ian Miller should read "That the Partnership delay any decision on the future of Leven Cottage until such time as full provision was in place with regard to nursing care facilities in Alexandria including the completion of such facilities."
- With regard to the item entitled "Update on Consultation on the Establishment of a West of Scotland Cardiothoracic Centre at Golden Jubilee National Hospital" (Page 1827, paragraph 6677 refers), it was noted that a further update report would now be submitted to the February 2006 meeting of the Partnership for Members' consideration.

PARTNERSHIP CONSTITUTION

LEVEN COTTAGE PROGRESS REPORT

- A report was submitted by the Acting Director of Social Work Services providing an update on the progress made towards the closure of Leven Cottage, involving consultation with residents, carers and trades unions.
- After discussion and having heard the Convener, Councillor Rooney, and the relevant officers in elaboration and in answer to Members' questions, the Partnership agreed:-
 - (1) to note the work undertaken to meet with residents, carers, staff and trades unions to identify issues and action required arising from the decision to close Leven Cottage; and
 - (2) to endorse the previous commitment to the provision of high quality Care Home provision in the Vale of Leven area.

PRIVATE SECTOR HOUSING GRANT (PSHG)

- A report was submitted by the Acting Director of Social Work Services advising of reduced funding for 2006/2007 in respect of the Private Sector Housing Grant.
- 7572 After discussion and having heard the Convener, Councillor Rooney, it was agreed:-
 - (1) to note, with concern, the contents of the report;
 - (2) that a further report dealing with the impact of the reduced level of grant on key issues would be submitted to a future meeting of the Partnership for consideration; and
 - (3) that the Acting Director of Social Work Services be authorised to explore possible alternative sources of funding with partner organisations, given the significant reduction in grant.

PARTNERSHIP DISCHARGE PROTOCOL

- A report was submitted by the Acting Director of Social Work Services requesting formal agreement to the Partnership Discharge Protocol, produced by Greater Glasgow NHS and Local Authority partners, including officers of West Dunbartonshire Council.

IMPLEMENTATION OF THE MENTAL HEALTH (CARE AND TREATMENT) (SCOTLAND) ACT 2003

- A report was submitted by the Acting Director of Social Work Services advising of the progress made towards the implementation of the Mental Health (Care and Treatment) (Scotland) Act 2003.
- 7580 After discussion and having heard the relevant officers in elaboration, the Partnership agreed:-
 - (1) to note the progress made towards ensuring that Council was in a position to meet its statutory duties and responsibilities;

- (2) to note the difficulty in terms of recruiting and retaining approved mental health officers and the consolidation of mental health services designed to minimise the risk of not delivering the requirements of the Act;
- (3) to approve an additional increment for Mental Health Officers (MHOs);
- (4) that the Acting Director of Social Work Services would monitor MHO recruitment and retention; and
- (5) that the Acting Director of Social Work Services would bring forward progress reports on how the new Act was being implemented in West Dunbartonshire.

VULNERABLE ADULTS

- A report was submitted by the Acting Director of Social Work Services advising of the adoption of procedures for the protection of Vulnerable Adults.
- 7582 Having heard the Acting Director of Social Work Services, the Partnership agreed to note the procedures and welcomed their introduction across West Dunbartonshire.

COMMUNITY HEALTH PARTNERSHIP (CHP) UPDATE

- A report was submitted by the Director of West Dunbartonshire Community Health Partnership advising of a further range of appointments by Greater Glasgow in conjunction with NHS Argyll and Clyde to the new CHP for West Dunbartonshire.
