- a) Target is to sustain current levels of service in line with the national direction of providing services which facilitate rehabilitation and enablement.
- b) The total population of concern here are (1) the number of people aged 65+ receiving 10 hours+ of home care, plus (2) the number of people resident in a care home, plus (3) the number of older people resident long term in hospital.
- c) WD CHCP contribution to overall NHSGGC target/trajectory for 2011/12 to be confirmed by NHSGGC.
- d) Contingent upon confirmation of number of GP practices within WD (1) eligible to, and then (2) choosing to participate in NHSGGC Keep Well programme (after which WD contribution to overall NHSGGC target would be set).
- e) National target to deliver 26 weeks referral to treatment from March 2013.
- f) Relate to new Community Payback Orders and will be set once baseline is established.
- g) National target to deliver 18 weeks referral to treatment from December 2014.
- h) National target of 90% by March 2013.
- i) National target to reduce rate between 2002 and 2013 by 20%.
- j) WD CHCP already exceeded sub-target to ensure 50% of identified frontline staff trained in suicide prevention during 2010/11.
