CHAIR'S REMARKS

The Chair, Councillor Robertson welcomed everyone present to the meeting of the Joint Committee and introductions were made around the table. In particular, the Chair welcomed Councillor Welsh to her first meeting of the Partnership Committee.

MINUTES OF PREVIOUS MEETING

The Minutes of Meeting of the Joint Committee held on 6 September 2012 were submitted and noted.

Having heard the Chair in relation to any matters arising from the Minutes of Previous Meeting, it was noted:-

- (1) that the full complement of staff for the prison based Social Work Services within HMP Low Moss was now in place; and
- (2) that a bid had been submitted to the Scottish Government for the development of the Public Social Partnership at HMP Low Moss to support transition from prison to the community in the provision of co-ordinated services to the prisoner population with public and third sector agencies working together within and beyond prison.

REDUCING RE-OFFENDING CHANGE FUND

A report was submitted by the Director of Community Health and Care Partnership providing information on progress on the action taken by the Criminal Justice Partnership with regard to Reducing Re-offending Change Fund.

A short presentation was provided by Mr Donnie McGilveray, Manager, Alternatives – West Dunbartonshire Community Drug Project on the process of a formal bid for funding from the Reducing Re-offending Change Fund which, if successful, would be available from April 2013.

COMMUNITY PAYBACK ORDER ANNUAL REPORT

Having heard the Partnership Manager - Criminal Justice in further explanation of the report, the Joint Committee agreed:-

- (2) that the Partnership Manager would issue a Briefing Note to Members on the inclusion of information and submission of requests for unpaid work in all three authorities; and
