APPLICATION FOR VARIATION OF PREMISES LICENCE

A report was submitted for consideration, application for Variation of Premises Licence for Atlantis Bar, 246-262 Kilbowie Road, Clydebank, G81 2JG.

Members heard from Neil Miller, Agent and representative for Atlantis Bar, Clydebank regarding the application and advising of the proposals and the considered guidelines discussed on the recent site visit from Members of the Licensing Board.

Having heard from Neil Miller, and in answer to Members' questions, the Board agreed to grant the application with the following stipulations being met:

- 1. The terminal hour of the outside area be set at 9.00 p.m. throughout the full week and not the 10.00 p.m. initially stated in the application;
- 2. The opening hour for the premises on a Sunday morning being 11.00 a.m.;
- 3. The internal capacity limit to be reduced to 327 with a new external capacity set at 60 maximum; and
- 4. Children and Young People are authorised to be on the premises for the duration of private functions.

The Board agreed to grant the application with the above stipulations in force.
