CHAIR'S REMARKS

Councillor Finn, Chair, welcomed everyone to the meeting which was being held remotely, in terms of Section 18B of the Civic Government (Scotland) Act 1982.

Accordingly, the Chair advised that a process/procedure had been developed for the meeting (a copy of which had previously been circulated to Members). Thereafter, the Committee agreed to note the procedure in place for the conduct of the meeting and the meeting then continued by video conferencing.

DECLARATIONS OF INTEREST

It was noted that there were no declarations of interest in any of the items of business on the agenda.

PRINCIPAL STREET TRADER'S LICENCE - UPDATE

A report was submitted by the Chief Officer – Regulatory and Regeneration providing an update on the grant of a Principal Street Trader's Licence to Mr Kieran Kilpatrick, 2 Wyvis Quadrant, Blairdardie, Glasgow G13 4LX.

It was noted that Mr Kilpatrick was in attendance at the meeting and was heard in answer to Members' questions.

DECIDED:-

After consideration and having heard the Section Head (Licensing) in further explanation of the report and in answer to Members' questions, the Committee agreed:-

- (1) to note the terms of the report including the update provided by Section Head (Licensing) in terms of the current updated planning position; and
- (2) that the decision of the Licensing Committee on 3rd February would remain in place until such time as planning permission is obtained by Mr Kilpatrick in terms of the separate planning procedures.

HEARING REGARDING POSSIBLE SUSPENSION OR REVOCATION OF A TAXI DRIVER'S/PRIVATE HIRE CAR DRIVER'S LICENCE

A report was submitted by the Chief Officer – Regulatory and Regeneration concerning a request from the Chief Constable of Police Scotland for the suspension or revocation of a Taxi Driver's/Private Hire Car Driver's Licence.

Having heard the Section Head (Licensing) in further explanation of the report, it was noted:-

- (a) that a letter had been received from the Chief Constable of Police Scotland on 12 February 2021 requesting the immediate suspension of the Taxi Driver's/Private Hire Car Driver's Licence under Paragraph 12(1) of Schedule 1 to the Civic Government (Scotland) Act 1982 on the grounds that carrying on of the activity to which the licence relates was likely to cause a serious threat to public order or public safety;
- (b) that having consulted with the Chair of the Licensing Committee, it was decided that, due to the content of the letter received from the Police, that the Taxi Driver's/Private Hire Car Driver's Licence held by the licence holder should be suspended with immediate effect under Paragraph 12 of Schedule 1 to the Act:

- that the Chief Constable had also requested the suspension of the Taxi Driver's/Private Hire Car Driver's Licence under Paragraph 11(1) of Schedule 1 to the Civic Government (Scotland) Act 1982 complaining that the licence holder was no longer a fit and proper person to hold a licence and also that the carrying on of the activity to which the licence relates was likely to cause undue nuisance or to be a threat to public order or public safety;
- (d) that in view of the request for suspension of the licence received from Police Scotland, the licence holder and a representative of Police Scotland had been invited to attend the meeting in order that a hearing could take place;
- (e) that the licence holder's current Taxi Driver's/Private Hire Car Driver's Licence had an expiry date of 1 December 2021;
- (f) that copies of the letter from Police Scotland had been issued to Members of the Committee in advance of the meeting; and
- (g) that the matters which the Committee required to consider in relation to paragraph (d) above were as follows:-
 - (i) whether the alleged misconduct had been established;
 - (ii) if the Committee was satisfied that the alleged misconduct had been established, whether, having regard to the misconduct, the licence holder was no longer a fit and proper person to hold a Taxi Driver's/Private Hire Car Driver's Licence and also whether the carrying on of the activity to which the licence relates was likely to cause a serious threat to public order or safety;
 - (iii) if the Committee was of the opinion that the licence holder was no longer a fit and proper person, then the Committee must consider whether the licence should be suspended;
 - (iv) if the Committee was satisfied that the licence should be suspended, the Committee must give the licence holder the opportunity to be heard on the length of the suspension and the date from which the suspension should commence;
 - (v) the Committee must then consider what length of suspension would be appropriate and whether the circumstances of the case would justify immediate suspension; and
 - (vi) that if the Committee was satisfied that the circumstances of the case justified revocation, the Committee must then consider whether this revocation should be immediate.

It was noted that the licence holder, and a representative of Police Scotland, Constable Raymond Borland, were in attendance. The Committee then heard from Constable Borland in relation to the letter from Police Scotland. Thereafter, both Constable Borland and the licence holder answered questions from Members.

Thereafter, the licence holder was given an opportunity to address the Committee on the circumstances detailed in the letter from Police Scotland and was again heard in answer to questions from Members.

DECIDED:-

After consideration and having heard the Section Head (Licensing) and the Senior Officer (Licensing Services) in further explanation of proceedings, it was agreed:-

- (1) that the alleged misconduct had been established; and
- (2) that the misconduct did not form grounds for suspending or revoking the licence at this time.

HEARING REGARDING POSSIBLE SUSPENSION OR REVOCATION OF A TAXI DRIVER'S/PRIVATE HIRE CAR DRIVER'S LICENCE

A report was submitted by the Chief Officer – Regulatory and Regeneration concerning a request from the Chief Constable of Police Scotland for the suspension or revocation of a Taxi Driver's/Private Hire Car Driver's Licence.

Having heard the Section Head (Licensing) in further explanation of the report, it was noted:-

- (a) that a letter had been received from the Chief Constable of Police Scotland on 19 February 2021 requesting the immediate suspension of the Taxi Driver's/Private Hire Car Driver's Licence under Paragraph 12(1) of Schedule 1 to the Civic Government (Scotland) Act 1982 on the grounds that carrying on of the activity to which the licence relates was likely to cause a serious threat to public order or public safety;
- (b) that having consulted with the Chief Officer Regulatory and Regeneration, it was decided that an immediate suspension was not appropriate in the circumstances under Paragraph 12 of Schedule 1 to the Act;
- (c) that the Chief Constable had also requested the suspension of the Taxi Driver's/Private Hire Car Driver's Licence under Paragraph 11(1) of Schedule 1 to the Civic Government (Scotland) Act 1982 complaining that the licence holder was no longer a fit and proper person to hold a licence and also that the carrying on of the activity to which the licence relates was likely to cause undue public nuisance or to be a threat to public order or public safety;
- (d) that in view of the request for suspension of the licence received from Police Scotland, the licence holder and a representative of Police Scotland had been invited to attend the meeting in order that a hearing could take place;

- (e) that the licence holder's current Taxi Driver's/Private Hire Car Driver's Licence had an expiry date of 13 May 2021 (extended by 3 months due to temporary changes to the Civic Government (Scotland) Act 1982, brought about by the Coronavirus (Scotland) Act 2020);
- (f) that copies of the letter from Police Scotland had been issued to Members of the Committee in advance of the meeting; and
- (g) that the matters which the Committee required to consider in relation to paragraph (d) above were as follows:-
 - (i) whether the alleged misconduct had been established;
 - (ii) if the Committee was satisfied that the alleged misconduct had been established, whether, having regard to the misconduct on the part of the licence holder, this had a bearing;
 - (iii) if the Committee was of the opinion that the licence holder was no longer a fit and proper person, then the Committee must consider whether the licence should be suspended;
 - (iv) if the Committee was satisfied that the licence should be suspended, the Committee must give the licence holder the opportunity to be heard on the length of the suspension and the date from which the suspension should commence;
 - the Committee must then consider what length of suspension would be appropriate and whether the circumstances of the case would justify immediate suspension; and
 - (vi) that if the Committee was satisfied that the circumstances of the case justified revocation, the Committee must then consider whether this revocation should be immediate.

It was noted that the licence holder, and a representative of Police Scotland, Constable Raymond Borland, were in attendance. The Committee then heard from Constable Borland in relation to the letter from Police Scotland. Thereafter, both Constable Borland and the licence holder answered questions from Members.

Thereafter, the licence holder was given an opportunity to address the Committee on the circumstances detailed in the letter from the Police authority and was again heard in answer to questions from Members.

1.1 To consider an application for grant of an Employee Street Trader's Licence submitted by Mr. Connor MacLeod, 431 Alderman Road, Knightswood, Glasgow G13 4HF.

2. Recommendations

2.1 It is recommended that the application be considered and determined by the Committee.

3. Background

- 3.1 Mr. MacLeod submitted an application for grant of an Employee Street Trader's Licence to the Council on 5 January 2021.
- 3.2 A letter was received from the Chief Constable of the Police authority on 18 March 2021 requesting that the Licensing Committee accept a late objection from the Police in relation to the application from Mr. MacLeod.
- 3.3 A further letter was also received from the Chief Constable of the Police authority on 18 March 2021 submitting an objection to the application

There is, however, provision in the legislation for the Licensing Authority to entertain a late representation which has been received before a final decision has been made if the Licensing Authority is satisfied that there is sufficient reason why the objection had not been submitted in the time required.
- 3.5 Mr. MacLeod has previously held an Employee Street Trader's Licence continuously between 21 April 2016 until 20 April 2020 but did not submit an application for renewal at that time.
