#### **SEXUAL ENTERTAINMENT VENUE LICENSING**

A report was submitted by the Chief Officer – Regulatory and Regeneration advising the Licensing Committee ("the Committee") on the responses received to the recently concluded consultation on the terms of its draft Sexual Entertainment Venue Policy Statement ("the Policy") and for the Committee to thereafter determine the terms of the Policy as well as the appropriate number of Sexual Entertainment Venues.

Having heard from the Section Head (Licensing), and in answer to Members' questions, the Committee agreed to set the number of Sexual Entertainment Venues in West Dunbartonshire and each relevant locality to Zero (Nil) and approve the Policy subject to it being updated with a note on the appropriate number of Sexual Entertainment Venues being agreed at Zero (Nil) and the reasoning for the determination being that without a licensing regime operators would be free to open Sexual Entertainment Venues across West Dunbartonshire without oversight by the Council and for the further rationale in the Policy.

The Section Head (Licensing) noted the Policy would be updated and come into effect on 17 May 2023.

# IMPACT ON THE CLYDEBANK TAXI TRADE FROM THE IMPLEMENTATION OF GLASGOW CITY COUNCIL'S LOW EMISSION ZONE

A report was submitted by the Chief Officer – Regulatory and Regeneration advising the Licensing Committee ("the Committee") of trade concerns relating to the impact of the implementation of Glasgow City Council's Low Emission Zone ("LEZ") on taxis licensed in the Clydebank zone.

Having heard from the Section Head (Licensing) and in answer to Members' questions, the Committee agreed:-

- (1) to note the implementation of Glasgow City Council's LEZ and the impact it would have on non-compliant taxis entering it;
- (2) to instruct officers to investigate what reasonable and proportionate steps can be taken, if any, to ameliorate the impact of the LEZ and what impact any steps will have on taxi users; and
- (3) to retain the policy of a 100% wheelchair accessible fleet within the Clydebank Zone.

#### SHORT TERM LETS LICENSING

A report was submitted by the Chief Officer – Regulatory and Regeneration advising the Licensing Committee ("the Committee") of an extension, approved by Scottish Ministers, for existing hosts to apply for a Short-Term Lets licence and the date by which all Short-Term Let operators must be licensed.

Having heard from the Section Head (Licensing) the Committee agreed:-

- (1) to note the terms of this report;
- to amend any reference to 1 April 2023 within the Committee's Short-Term Lets Policy to 1 October 2023;

- (3) to amend any reference to 1 July 2024 within the Committee's Short-Term Lets Policy to 1 January 2025; and
- (4) to delay the review of its Policy and its implementation from 18 to 24 months from its adoption to 24 to 30 months.

Having heard from Mr. McDougall, Section Head – Licensing and Sergeant David Holmes, Police Scotland and in answer to Members' questions, the Committee

agreed to suspend the Taxi Driver's/Private Hire Car Driver's Licence with immediate effect, for the remainder of the term of the Licence, due to the holder not being considered a fit and proper person to hold the Licence.

#### Licensing Committee – 14 June 2023

Subject: Hearing regarding possible suspension or revocation of a Late Hours Catering Licence

#### 1. Purpose

1.1 To consider a request from the Chief Constable of Police Scotland for the suspension of a Late Hours Catering Licence held by Mr. Shafiqullah Khalil for the premises, Aladdin Hot For You located at 6 High Street, Dumbarton G82 1LL. Members also have the option to revoke the licence.

#### 2. Recommendations

2.1 The Committee are asked to consider the terms of this report, the terms of the letter from the Chief Constable and any evidence presented at the hearing and thereafter determine whether the licence should be suspended and, if so, the duration of the suspension and date of commencement thereof or alternatively revoke the licence.

#### 3. Background

- 3.1 On 17 May 2023, a letter was received from the Chief Constable of Police Scotland requesting the immediate suspension of the Late Hours Catering Licence held by Mr. Khalil under Paragraph 12(1) of Schedule 1 to the Civic Government (Scotland) Act 1982 on the grounds that the carrying on of the activity to which the licence relates is likely to cause a serious threat to public safety.
- 3.2 Having consulted with the Chief Officer, Regulatory and Regeneration, it was decided that the Late Hours Catering Licence held by Mr. Khalil did not merit an immediate suspension under Paragraph 12 of Schedule 1 to the Act.
- Mr. Khalil previously held a Late Hours Catering Licence for the premises having been granted the licence at Committee on 20 February 2019. The licence expired on 19 February 2022 and no renewal application was submitted at that time.
- 3.4 Mr. Khalil's current Late Hours Catering Licence has an expiry date of 23 June 2025 having had the licence granted on 24 June 2022 The operating hours of the Late Hours Catering Licence are:-

Monday 11.00 pm to 1 am 11.00 pm to 1 am 11.00 pm to 1 am

Thursday
11.00 pm to 1 am

#### 4. Main Issues

- 4.1 In his letter the Chief Constable also requested a suspension of the licence under Paragraph 11 of Schedule 1 to the 1982 Act. A licensing authority may, in these circumstances, order the suspension or revocation of a licence under Paragraph 11 if, in its opinion:-
  - (a) the holder of the licence is not, or is no longer, a fit and proper person to hold the licence and/or;
  - (b) the activity to which the licence relates is being managed by or carried on for the benefit of a person, other than the licence holder, who would have been refused the grant or renewal of the licence under paragraph 5(3) and/or;
  - (c) the carrying on of the activity to which the licence relates has caused, is causing or is likely to cause undue public nuisance or a threat to public order or public safety and/or;
  - (d) a condition of the licence has been contravened
- 4.2 The period of suspension of a licence is the unexpired portion of the duration of the licence, or such shorter period as the licensing authority may fix.
- 4.3 Where a licensing authority decides to order the suspension or revocation of a licence, the suspension or revocation generally does not take effect until the expiry of the time within which the holder of the licence may appeal against the suspension or revocation (28 days from the date of the decision to suspend) or, if an appeal has been lodged, until the appeal has been abandoned or determined in favour of the suspension or revocation. However, if the licensing authority determines that the circumstances of the case justify immediate suspension or revocation, it may order that the licence be suspended or revoked immediately.
- 4.4 A licensing authority must, before deciding to suspend or revoke a licence under Paragraph 11, give the holder of the licence and the Chief Constable an opportunity of being heard.
- 4.5 The licence holder and a representative of the Chief Constable have been invited to the meeting of the Committee on 14 June 2023 in order that a hearing may take place with regard to the possible suspension or revocation of the licence.

- 4.6 In considering whether to suspend or revoke a licence the licensing authority may have regard to any misconduct on the part of the licence holder which in the opinion of the authority has a bearing on his fitness to hold a licence.
- **4.7** The matters which the Committee will require to consider in relation to paragraph 4.1 above are as follows:-
  - (a) Whether the alleged misconduct has been established.
  - (b) If the Committee is satisfied that the alleged misconduct has been established, whether, having regard to the misconduct on the part of the licence holder, this has a bearing on Mr Khalil's fitness to hold a licence.
  - (c) If the Committee is of the opinion that Mr. Khalil is no longer a fit and proper person, or the activity to which the licence relates is being managed by or carried on for the benefit of a person, other than the licence holder, who would have been refused the grant or renewal of the licence under paragraph 5(3), or that the carrying on of the activity has caused, is causing or is likely to cause undue public nuisance or a threat to public order or public safety, the Committee must consider whether his licence should be suspended or revoked.
  - (d) If the Committee is of the opinion that a condition of the licence has been contravened then it may order the suspension or revocation of the licence.
  - (e) If the Committee is satisfied that the licence should be suspended, the Committee must give Mr. Khalil an opportunity of being heard on the length of the suspension and the date from which the suspension should commence.
  - (f) The Committee must then consider what length of suspension is appropriate and whether the circumstances of the case justify immediate suspension.
  - (g) If the Committee is satisfied that circumstances of the case justify revocation, the Committee must consider whether the circumstances of the case justify immediate suspension of the licence as well as revocation.
