- (i) 103 Antonine Gardens, Clydebank (DC06-175)**
- (ii) 13 & 15 Burnside Crescent, Clydebank (DC06-317)**

#### **1. Purpose**

- 1.1** To inform the Committee of the determination of one planning appeal and the submission of another.

#### **2. 103 Antonine Gardens, Clydebank (DC06-175)**

- 2.1** The appeal against the refusal of the erection of decking on the front elevation of a detached house was dismissed. The appeal was dealt with by way of written submissions. The Reporter considered that the proposal would not comply with local plan policy GD1 and there would be a significant loss of privacy.

#### **3. 13 & 15 Burnside Crescent, Clydebank (DC06-317)**

- 3.1** Planning permission was refused for the erection of a two storey side extension to these flats on 10 November 2006. It was refused on the grounds that it was contrary to Policy GD1 and H5 of the Clydebank Local Plan as it would have an adverse visual effect on the site and surrounding area as a result of its scale, size and position. The extension would also dominate the neighbouring properties at 9 and 11 Burnside Crescent because of its proximity to their front elevations and front garden area and would also adversely affect their amenity because of an increase in overshadowing.
- 3.2** The appellants wish the appeal to be decided on the basis of written submissions.
