Proposed Theatres Act Licence Conditions

- The provisions of the Theatres Act, 1968, and any Regulations which may be made under the said Act shall be carried out and the conditions of this licence shall be fulfilled to the satisfaction of the Head of Legal, Democratic and Regulatory Services.
- 2. The Public shall be allowed to leave the premises by all exit doors.
- 3. A push bell, buzzer or other similar device shall be provided to enable the operator within the stage lighting room to communicate with the person who has control of the general lighting of the auditorium outside, in order that stage lighting does not interfere with the safe evacuation of the premises.
- 4. The use of pyrotechnics or naked flames, i.e. candles or lamps may only be used with the prior consent of the Licensing Authority in conjunction with Strathclyde Fire and Rescue.
- 5. All drapes, backdrops and other stage dressings should be constructed entirely of a fire retardant material. If it is not possible for such items to be comprised of fire retardant materials then steps, such as using a fire retardant spray should be taken to improve the fire retardation qualities of such materials.
- 6. This Licence may be revoked or suspended by the Licensing Authority in the event of any failure on the part of the licensee to comply with the conditions of this licence, or if the building or equipment within should become unsafe or if any material alteration is made in the building or its internal layout without the prior consent of the Licensing authority.
- 7. At any entertainment, especially for children, such children shall not be admitted to the balcony or gallery unless accompanied by a parent or guardian over sixteen years of age. The maximum number of children under the care or control of such parent or guardian shall not exceed ten.
- 8. There shall be prominently exhibited at each public entrance whenever the premises are open to the public, a notice indicating (a) the title of each performance to be shown on that day; and (b) the approximate times of commencement of each such performance.
- 9. Where the Licensing Authority has given notice in writing to the licensee of the premises objecting to an advertisement on the ground that, if displayed, it

would offend against good taste or decency or be likely to encourage or incite crime or to lead to disorder or to be offensive to public feeling, that advertisement shall not be displayed at the premises except with the consent in writing of the Licensing Authority.

- 10. In special cases the Licensing Authority may dispense with or modify these conditions as they see fit.
- 11. This Licence shall continue in force for one year from the date it was granted or renewed unless previously revoked or suspended.
- 12. The premises are licensed to accommodate.....persons and no greater number of persons shall be permitted entry.
- 13. Recording of footfall. Throughout the duration of any event or performance the premises shall utilise an accurate count of the number of persons present within the premises.
- 14. The licence holder shall ensure that fly posting does not take place to advertise events occurring on the premises. The Licence holder shall ensure that all contracts/hiring agreements relating to the use of the premises by a third party will contain a requirement that the promoters or any other companies will not engage in or authorise any other person to engage on fly posting.
- 15. The Licence holder shall ensure that publicity material advertising events occurring on the premises is not distributed in such a manner as to produce litter.
- 16. The Licence holder shall ensure that there is a provision of litter receptacles outside the venue.
- 17. The Licence hold shall have a duty of care contract in place at all times to cover the collection of waste.
- 18. The Licence holder shall ensure that there is adequate provision of fire fighting equipment within the premises. Furthermore a scheme for ensuring these appliances are tested periodically in line with the relevant guidance should be incorporated and actioned.
- 19. The Licence holder shall have a plan in place which allows for the safe evacuation of patrons in the event of any emergency on the premises. Any plan put in place will be adequately communicated to staff members and tested periodically.
- 20. The Licence Holder shall undertake to fully test the fixed electrical supply every five years and partial tests of this electrical supply shall occur annually.
