# **DECLARATIONS OF INTEREST**

It was noted that there were no declarations of interest in any of the items of business on the agenda.

### **UPDATE ON ROADS AND ROUNDABOUTS ISSUES**

Raymond Walsh, Network Management Services Co-ordinator, West Dunbartonshire Council, provided a verbal update on this item.

After discussion and having heard Mr Walsh in further explanation and in answer to Members' questions, the Committee agreed:-

- (1) to note the terms of the update on Roads and Roundabouts in the area;
- (2) to note that any concerns in relation to issues surrounding roads and roundabouts should be communicated to the Traffic Section of the Housing, Environmental and Economic Development Department in order that these matters could be taken forward and addressed;
- (3) to note that an invitation would be extended to Transport Scotland to attend a future meeting of the Committee in order to enable further discussion to take place on roads infrastructure at key areas such as Lomondgate Roundabout; Dumbarton; and
- (4) to note that all community groups had been sent information on the Snow Code and winter prevention advice and that any groups wishing more supplies of the leaflets should contact the Clerk with their request.

# PRESENTATION - WEST DUNBARTONSHIRE ALCOHOL AND DRUG STRATEGY 2011-2014

A presentation on the above was given by Ms Helen Weir and Mr Tom Jackson of the West Dunbartonshire Community Health and Care Partnership.

## PRESENTATION - REGENERATION IN WEST DUNBARTONSHIRE

Mr Jim McAloon, Head of Regeneration and Economic Development and Mr Michael McGuinness, Economic Development Manager, gave a presentation on regeneration in West Dunbartonshire.

After discussion and having heard Messrs. McAloon and McGuinness in elaboration and in answer to Members' questions, the Committee agreed:-

- (1) to note the terms of the presentation on regeneration in West Dunbartonshire particularly in relation to the progress and positive impact it was having on the communities of Clydebank, Dumbarton and Alexandria;
- (2) that a copy of the presentation slides be sent to Members of the Committee for their interest and information; and
- (3) that it would be useful to have a presentation on the Tourism Strategy at a future meeting of the Committee.

### MINUTES OF PREVIOUS MEETING

After discussion and having heard the Policy Officer in further explanation and in answer to Members' questions, the Committee agreed:-

- (2) that having had the draw, which had been carried out by Carolyn Leckie, Clydebank Women's Aid, to note that the successful groups or organisations were:-
  - (a) Clydebank Asbestos Group; and
  - (b) Renton Community Development Trust.

(3) to note the terms of the discussion that had taken place on widening the membership of the Committee and that this would be done as part of the review of the Committee to take place during 2012. In this respect, it was suggested that one of the future meetings could be used specifically to discuss membership.
