In terms of section 36(1) of the Licensing (Scotland) Act 2005 the Chief Constable hereby makes application to the Licensing Board for a review of the premises licence in respect of the premises known as Cheers Licensed Grocers (formally known as Madan Stores), 2, Dalgleish Avenue, Duntocher, Clydebank, G81 6DU

The Chief Constable makes application in terms of section 36(3)(b) of the Act on grounds relevant to one or more of the licensing objectives articulated at Section 4(1) of the 2005 Act, namely;

- preventing crime and disorder.

In support of this application, the following information is provided for your consideration.

About 1830hrs on Tuesday 1 March 2011, Mr Anil Randev (the licence holder) was working within the premises of Cheers Licensed Grocers, 2, Dalgleish Avenue, Duntocher, G81 6DU. At this time Mr Randev became involved in an altercation with a female. Mr Randev requested that the female leave the premises. As she did so she was observed to remove a packet of sandwiches and a plastic pot of pasta from the chilled cabinets and left without paying. Mr Randev is then alleged to have pursued the female from the shop and on catching her shouted, swore then proceeded to kick her to the legs and body as well as punching her about the face. Two members of the public allege that they pulled Mr Randev from the girl before Mr Randev made his way back into the shop followed by them and the female. The


female is then alleged to have pulled over a cake stand, shouted and swore at Mr Randev before leaving the area of the shop. Mr Randev then called the police to report a theft from the shop. Subsequent enquiry failed to trace the female involved in the alleged theft and the victim of the alleged assault. These enquiries revealed sufficient evidence provided by independent civilian witnesses for Mr Randev to be charged with assault on the unknown female and a report to be submitted to the Procurator Fiscal at Dumbarton.


As this matter is sub judice I am constrained with regards to the nature of any further information that I can provide at this time.

As of today's date, the 11 May 2011, the Procurator Fiscal at Dumbarton has not set a date for any proceedings.

If satisfied that a ground for review has been established, Your Honours may wish to consider appropriate action under the terms of section 39(2) of the Act, for the purpose of securing the licensing objectives.
