# Subject: Glasgow City Region City Deal - Update

#### 1. Purpose

**1.1** To update members and note the progress with the implementation of the Glasgow City Region City Deal.

### 2. Recommendations

- **2.1** It is recommended that Council:
  - i) notes the progress with the implementation of the Glasgow City Region City Deal.

### 3. Background

**3.1** The Glasgow City Region City Deal Infrastructure programme equates to £1.13bn of investment for 20 projects over a ten year period. These projects are progressing and have reached various stages from Strategic, Outline and Full Business cases stages of approval.

#### 4. Main Issues

**4.1** As part of a City Region approach the City Deal Cabinet have approved a number of portfolio areas to be managed across the Local Authorities with Council leaders and a Chief Executive as portfolio lead, a senior officer lead and a number of support officers as per table 1 below.

The role of the portfolio holder is to:

- Respond on behalf of the Cabinet on announcements that relate to their policy portfolio;
- Lead conversations on behalf of Cabinet on with Government on issues that relate to the delivery of City Deal Cabinet policy objectives, as established as part of an agreed portfolio workplan;
- Represent Cabinet in political engagement at Scottish Government Cabinet Secretary/ Ministerial Level.

- **4.2** One of the most important drivers of growth will be increasing the size and performance of the company base in the City Region. The current structures to do this are split across the 8 participating Councils and a number of other public and private bodies. These structures pre-date and do not directly involve the City Deal. Therefore the City Deal Cabinet has commissioned a review of Enterprise Services to explore how support for growing the business base might best be delivered in the City Region in the future. This work has now been completed and will be reported to City Deal Cabinet on 16th August 2016. A verbal update will be provided at Council.
- **4.3** One of the main outcomes of the City Deal infrastructure investment is a significant increase in the accessibility of new employment opportunities. If the benefits of the investment in infrastructure under the City Deal are to be distributed across the population of the City Region, the local workforce will have to be equipped with the skills and capacity to take advantage of these opportunities. Therefore in a similar way to the enterprise support review a review of employability and skills development support is being carried out by University of Glasgow from a city region perspective. The conclusions of this work will be reported to Council in due course.
- **4.4** The City Deal Cabinet has also commissioned the production of an economic strategy for the City Region. That strategy is due to be brought to the Cabinet in the autumn, and will be reported in due course.

### 5. Overall Infrastructure Programme Update

**5.1** The Glasgow City Region City Deal Infrastructure projects led by Local Authorities are on schedule as of August 2016. The following were approved on 16 August 2016 by the Cabinet as follows:

- The South Lanarkshire Council Outline Business Case for Greenhills Road / A726 Strathaven Dual Carriageway Road Improvements was presented. This Outline Business Case sought funding of £1.5m to progress the project to a Full Business Case.
- Renfrewshire Council have sought revised phasing of costs for Clyde Waterfront and Renfrew Riverside Project (CWRR) and the Glasgow Airport Investment Area (GAIA). There are no changes to the overall costs of the two projects.

# 5.2 Regional Economic Development Group Update

**5.2.1** The Commission on Economic Growth chaired by Professor Muscatelli has recently been established and will develop its work plan by autumn 2016. Their role and remit which was agreed at Cabinet on June 2015, with a further update on June 2016, is to design a monitoring and evaluation methodology for the City Deal Programme; to advise Cabinet on regional economic strategy; participate in the procurement of the National Panel; liaise with the National Panel on behalf of the Glasgow City Region City Deal in identifying national and local indicators; establishing requirements and preparing for the gateway review ensuring capture of qualitative data.

# 5.3 Finance Group Update

- **5.3.1** The finance group have mainly been involved in reviewing the year end accounts, including the audit of the accounts for 2015/16. Other tasks included reviewing the reporting requirements for 2016/17 for all funding streams, reviewing the PMO budget projection for 2016/17, and review of known commitments for 2017/18.
- **5.3.2** The grant allocations to Member Authorities for 2016/17 have been reviewed and a paper will be submitted to Cabinet for formal notification.

# 5.4 Labour Market Working Group (LMG) Update

- **5.4.1** The City Deal ESA support programme (Working Matters) is designed to assist people to develop a plan and the relevant skills to seek and secure sustained employment and to become more resilient within the labour market.
- **5.4.2** While we expect participants to have considerable barriers to inclusion, the barriers experienced by participants in West Dunbartonshire appear to be more severe than the average for the overall City Region area:
  - 79% of clients have Mental Health issues (overall programme 73%);
  - 52% have a physical illness (overall programme 49%);
  - 55% have no qualifications (overall programme 34%);

- 24% have a history of alcohol abuse (overall programme 19%);
- 21% have a history of substance abuse (overall programme 13%);
- **5.4.3** The programme is planned to run for a period of three years and it is anticipated **239** people will be supported over the length of the programme, across the city region. To date, **33 of the 46** clients referred to the programme by DWP staff in West Dunbartonshire are actively engaging.
- **5.4.4** The challenges in the forthcoming period centre on maintaining good levels of engagement and participation among the group, providing mental ill-health provision to address some of the major barriers and tackling debt issues. Further development in these areas, in order to assist participants into work, is a focus of the team's work over the next six months.

# 6. WDC City Deal Project

- **6.1** The Exxon City Deal project for WDC has planned expenditure of £27.897m over the next seven years. The project is progressing towards an Outline Business Case for submission in February 2017.
- **6.2** The project at the Exxon site is progressing with a welfare facility having been established on the site for use of WDC and our specialist contractors to carry out a series of studies. As agreed at Council at June 2016 further details relating to the Exxon project itself will now be presented at future IRED committees as appropriate.

### 7. **People Implications**

**7.1** There are a number of senior officers involved in the Glasgow City Region City Deal initiative across services of the Council and as part of the project board.

### 8. Financial and Procurement Implications

- **8.1** The finance required to progress with the City Deal project and the support from the PMO can be met within existing budget allocated.
- 8.2 There are no procurement issues related to this report.

### 9. Risk Analysis

**9.1** Funding from the Glasgow City Region City Deal Fund is at risk if the overall project does not ultimately proceed. The risk of this is being managed by the Councils own project management processes.

# 10. Equalities Impact Assessment (EIA)

**10.1** As the paper is for noting, no further Equalities Impact Assessment is required. If any matters are brought to Council for decision, an Equalities Impact Assessment will be produced.

# 11. Strategic Environmental Assessment

**11.1** A pre-screening Strategic Environmental Assessment will be developed once agreements on the site acquisition terms have been agreed with the site owner.

### 12. Consultation

- **12.1** As part of the wider consultation the City Deal Newsletter entitled 'we connect' has been produced and distributed and is provided as appendix 1 for information.
- **12.2** Consultation with all key stakeholders is progressing as we develop the Outline Business Case.

### 13. Strategic Assessment

- **13.1** This report contributes to the Council's Strategic Priorities and in particular towards:
  - economic growth and employability; and
  - local housing and sustainable communities.

# Completion of First City Deal Infrastructure Sub Project at East Renfrewshire

In early July, East Renfrewshire Council celebrated the completion of work at Crossmill Business Park in Barrhead, marking an important milestone for the City Deal and demonstrating the ambition of supporting

# business growth and creating employment opportunities.

Councillor Tony Buchanan, East Renfrewshire Council Convener for infrastructure and sustainable growth, commented: "City Deal is great news for East Renfrewshire. Our ambitious vision for the future development of the area has been enhanced and accelerated thanks to our £44 million City Deal investment. Flexible commercial units are now open for business at Crossmill Business Park and a 17-acre former factory site has been prepared for private investment, supporting business growth and providing employment opportunities."

Three local businesses are already set to move into the units which will provide the additional space needed to further their expansion plans. Community Benefits as part of the contract allowed site contractor, WH Malcolm, to offer work experience placements to young apprentices, one of whom Cameron Laidlaw, has secured a permanent job with the company.

# A New Look for the City Deal

The creation of a brand for the Glasgow City Region City Deal demonstrates successful partnership working across the Region.

A two-stage approach was adopted by the eight Heads of Comms and Marketing for the creation of the brand, with an initial independent consultation exercise carried out ensuring the views of over 70 regional partners were taken on board. Findings and recommendations informed the subsequent creation of the communication strategy, the brand design and provided an agreed new name for the partnership - from the Glasgow and Clyde Valley City Deal to the Glasgow City Region City Deal. A team of designers from across the member authorities then developed the new brand design which fittingly represents the solidity of the partnership and references all member council brand colours.

# National Panel and Commission on Economic Growth

A detailed evaluation of the City Deal will be built around five yearly Gateway Reviews.

A number of cities/city regions across the UK have secured funding as part of individual City Growth and Devolution Deals agreed with the UK Government. While each deal is different, the common thread is that well-targeted investments at a city region level can unlock economic growth in city regions and nationwide.

For reasons of consistency and cost, a single approach to evaluation across the localities in receipt of the funds has been proposed by the UK Government. However, as the Glasgow City Region City Deal is funded by equal contributions from the Scottish and the UK Government, the intention is that the national evaluation will be complemented with additional activity specific to the Glasgow City Region, recognising additional and complementary priorities.

More detailed plans are now being progressed for a National Evaluation Panel and a local Glasgow City Region Commission on Economic Growth.

Working in partnership, nine UK City Regions (Glasgow, Greater Cambridge, West Yorkshire, Greater Manchester, Sheffield, North East, Tees Valley, West Midlands and Liverpool) are seeking to appoint a National Evaluation Panel, an independent advisory panel to oversee the rigorous economic impact evaluation of their programmes of local growth interventions, to inform how further allocations of funding will be made by Government at five yearly Gateway Reviews, which are a feature of all the individual deals. An assessment of the work required by the panel is underway. Once completed, a procurement exercise to appoint panel members will commence, led by Transport for Greater Manchester on behalf of the Greater Manchester Combined Authority.



The Commission on Economic Growth, chaired and led by Professor Anton Muscatelli (pictured), Principal of the University of Glasgow, met for the first time in June. The Commission will act as the principal economic advisers to the Cabinet and will also provide input to the National Panel and its development of the UK core evaluation methodology. The Commission will link in with the Scottish Government and its key policy objectives, most notably promoting inclusive growth, whilst recognising the key policy and delivery role of local authorities and their partners. The immediate activities of the Commission involve a review of the remit, development of a work plan and engagement with a number of stakeholders with the intention of presenting a work plan to Cabinet in October 2016.



# **BUSINESS GROWTH AND INNOVATION**

The Business Growth and Innovation Theme aims to support the development of small and medium enterprises and stimulate further growth in the life science sector through the establishment of world class research and development and commercialisation facilities. The Glasgow City Region City Deal will not only deliver tens of thousands of jobs and massive infrastructural improvements over the next few decades, but also continue the City Region's rise as a leader in innovative industries such as life sciences, advanced design and manufacturing and new technologies.

A key aim of the Glasgow City Region City Deal is the creation of innovation and growth through the support of these key industries. There are three innovation hubs in the Glasgow City Region supported by this City Deal: the Centre for Business Incubation and Development at the Tontine building in Glasgow's Merchant City; the University of Glasgow's Imaging Centre of Excellence, based at the Queen Elizabeth University Hospital campus; and Medicity Scotland in Newhouse, North Lanarkshire.



# The Tontine

The £4 million centre for business incubation and development, which opened in May, will support high-growth companies in the enabling technology, advanced design and manufacturing, and creative economy sectors, with between 5 to 20 employees.

The Tontine beside Glasgow Cross will host high-quality and flexible

workspaces for these companies, with a focus on those sectors which link with Strathclyde University - to maximise cross-fertilisation between growing companies in the city and major multi-nationals and research programmes situated close by.

There are three components parts to this exciting new addition to the City Region's economy: the Centre for Civic Innovation, where innovation through collaboration between the public sector and private enterprise (particularly small and medium sized businesses) will be explored; the Open Innovation Pilot Programme, where best practice on the development and commercialisation of innovative technology will be shared and developed; and DEMOLA, an international platform for the co-creation of new products or services and hosted in partnership with Scottish Enterprise.

In the next five years, it is expected that 134 businesses will be supported at the centre, with each increasing their staff numbers by at least four per business. This will result in the creation of 536 new jobs resulting in an increased turnover of £53.6 million over the term of the programme.

# The University of Glasgow's Imaging Centre of Excellence (ICE)

The University of Glasgow's Imaging Centre of Excellence (ICE), which is supported by £16 million of government funding through the Medical Research Council as part of the Glasgow City Region City Deal, is expected to open in early 2017. Based at the Queen Elizabeth University Hospital

campus, the ICE will house state-of- the-art technology to enable scientists to conduct new clinical research using advanced imaging.

The ground floor of the building will accommodate a £7 million 7 Tesla Magnetic Resonance Imaging (MRI) scanner. The 7 Tesla MRI scanner is an ultra-high resolution scanner which will allow the development of advanced diagnostic imaging methodologies for use in stroke, brain imaging, cardiovascular and inflammatory diseases. ICE is expected to generate around 400 new jobs and

add nearly £85 million for the local economy over the next seven years. Alongside University of Glasgow researchers, corporate partners represented on site will include a range of large companies and SMEs in the diagnostics and medical imaging fields. The building will also accommodate clinical academic imaging specialists and clinical physics experts.

A celebratory topping-out ceremony took place in early July to mark good progress on the build programme.

# MediCity

MediCity Scotland is a dedicated medical technology incubation facility based at Biocity Scotland Ltd.

The £4.6 million facility brings together academics, entrepreneurs, clinicians and business support services to assist the development of new healthcare services and medical technology.

A total of 11,000 square feet has been established through the refurbishment of an existing building at the BioCity campus. This state-of-the-art facility offers a choice of flexible office space, workshops and laboratories for new and existing medical technology and healthcare businesses in Scotland, thereby acting as a focus for expertise in the sector.

MediCity Scotland provides companies an environment in which businesses are more likely to be successful. In addition, to the space, MediCity also offers business training and coaching, help with access to finance



and connections to an industry wide network.

The facility aims to support up to 150 new med-tech jobs by 2021, develop links between the commercial and academic communities and showcase Scotland to inward investment opportunities in this growing field. In addition, over the next five years MediCity Scotland is expected to deliver:

- 20 workshops/development programmes/events;
- dedicated support for up to 80 med-tech companies;
- leverage up to £5.6 million of additional investment from supported companies;

 assist in the creation of 19 new companies and the launch of 40 products.

As of the end of Q2, the MediCity Scotland Team has delivered one DEVELOP Business Acceleration Programme and will be supporting a number of companies on a one to one basis. 20 participants completed our first Bootcamp in early June and over 130 industry representatives have attended events on site.

East Renfrewshire's £44 million City Deal investment is focused on six key projects around the M77 Strategic Corridor.

Projects have been designed to deliver the infrastructure to support and enhance the place making strategy adopted through the Council's Local Development Plan (LDP).

The City Deal team is made up of representatives from across the council including; economic development, finance, procurement, legal and roads. A number of dedicated officers have joined the economic development team led by Gillian McNamara, Economic Development and Regeneration Manager, to help manage City Deal infrastructure projects and marketing.

Officers meet every six weeks at a City Deal liaison meeting, chaired by Iain MacLean, Head of Environment. Updates from City Deal sub-groups are discussed along with project progress, actions and future plans. A quarterly Regeneration Board chaired by Environment Director Andrew Cahill and attended by Chief Executive Lorraine McMillan, provides a forum for discussion, management approvals and overall strategic input.

#### Levern Works, Barrhead

Modern, flexible commercial units of 72 sqm (995 sqft) are now available to lease at Crossmill Business Park. A 17-acre former factory site has been prepared for private investment through remediation and ground formation works (this project was also funded and supported by Scottish Ministers, COSLA, the Scottish Government Regeneration Capital Grant Fund).

#### Dams to Darnley Country Park

Exciting plans are in place to transform East Renfrewsire's hidden gem into a must visit leisure destination including a wake park, visitor centre and boardwalk with improved accessibility for the communities of East Renfrewshire and beyond.

#### **Enhanced road network**

Surface transport connectivity, including pedestrian routes, will be improved between the communities of Barrhead, Newton Mearns and the M77. The first works are programmed to commence in 2017 with the realignment of sections of Aurs Road.

#### New railway station

A new purpose built railway station and bus interchange is planned for opening at the end of 2019 at Barrhead South. On the Glasgow to Neilston line, it will improve access to jobs, services and communities.

#### **Greenlaw Business Centre**

Meeting a growing demand for flexible business space, a new business centre with office and workshop space is coming to Newton Mearns. Completed by the end of 2018 it will provide support for start-ups and micro businesses.

#### Foundry links

Building on the success of Barrhead Foundry, additional business space and learning opportunities will be created in Barrhead town centre.
