APPEAL AGAINST STAGE 2 OUTCOME - GRIEVANCE (REF: APP/24/01)

There were submitted background papers relating to an appeal that had been submitted to the Council in relation to the outcome of a stage 2 Grievance Hearing.

The Appellant was present and represented by his Trade Union Representative Mr David Smith (Unison).

Mr Peter Hessett, Chief Executive was in attendance to present the case on behalf of Management. Ms Leeanne Galasso, People and Change Partner, was in

attendance as a Human Resources Adviser to Mr Hessett.

The Committee by way of a preliminary matter having heard from Mr Smith and Mr Hessett decided not to admit documents A5 and A19 as submitted by the Appellant and noted that Mr Smith was withdrawing document A1.

The Chair reminded Mr Smith that the purpose of the Appeal Committee was to consider the part of the grievance not upheld at Stage Two of the grievance procedure, namely the allegation of bullying.

Mr Smith presented the case for the Appellant. Mr Smith and the Appellant then answered questions from Mr Hessett and Members of the Committee.

Mr Hessett then presented the case for Management and thereafter answered questions from Mr Smith and Members of the Committee.

Mr Hessett and then Mr Smith and the Appellant summed up their respective cases and thereafter both parties withdrew from the meeting.

After the Committee had deliberated the matter in private in the presence of the Legal Officer and Human Resources Advisor to the Committee, both parties were readmitted to the meeting and advised that the grievance was not justified and the grounds of the appeal had not been upheld.

The Legal Officer advised that the decision would be issued in writing.
