## **Subject: Community Participation Committee (CPC) - Evaluation**

#### 1. Purpose

**1.1** This report provides the CPC evaluation feedback and makes recommendations based on the feedback.

#### 2. Recommendations

2.1 In conclusion, a high majority of respondents think the Committee is working effectively in providing relevant information and offering opportunities to comment on policies and on consultation mechanisms and arrangements. Areas for improvement should be addressed by the following recommendations.

Committee members are invited to agree the following:

- Community members should use the regular agenda item 'Future Agenda
  Items for Community Representatives' to query delays and request changes
  to the order of scheduling of future agenda items if desired (subject to there
  being something of relevance to report).
- The introduction of a brief 'Feedback' section to the CPC Newsletter (to respond to the need to improve dialogue and feedback).
- Scheduling of agenda items will allow more time for community members to consult their groups wherever possible.
- Community representatives are invited to include group updates in the CPC Newsletter.
- **2.2** Community representatives are invited to make their role on the Committee more effective by:
  - Ensuring their group agendas include the CPC as a standing item.
  - Asking their group for relevant agenda items.
  - Asking for views on agenda items.
  - Asking for items for the 'Community News' agenda slot.
  - Circulating the CPC Newsletter to their group. All the newsletters are on the
    Council website and can be accessed at <a href="http://www.west-dunbarton.gov.uk/community-and-living/involving-communities/cpc/">http://www.west-dunbarton.gov.uk/community-and-living/involving-communities/cpc/</a>. Anyone
    wishing the CPC Newsletter sent via email, should contact Community
    Planning and Policy on 01389 737231.

2.3 To help broaden membership, in response to views expressed, the Committee is asked to recommend the following to Council:

Agreement is sought for the Policy Officer Community and Consultation to contact appropriate groups to invite interest in additional places for Women's issues, Ethnic Minority Women and LGBT (Lesbian, Gay, Bi-Sexual and Transgender).

**2.4** It is suggested that Committee Members are invited to participate in Equalities Awareness Training.

### 3. Background

- 3.1 The Community Participation Committee was set up following the Local Government Elections in May 2003 at the Council meeting of 25 June.
- 3.2 The Committee's role and remit in the standing orders (revised July 2009) is to:-
  - Provide a forum for obtaining the views of community based organisations.
  - Co-ordinate discussion and action on issues raised by community groups and forums.
  - Consider comments and suggestions from community based organisations about Council services.
  - Consider, promote, and monitor Council consultation arrangements, participation structures and policies and also wider public involvement structures and community engagement arrangements.
  - Encourage Social Inclusion and Equality.
  - Encourage Health Improvement.
  - Co-ordinate community involvement in the ongoing development and review
    of the Council's Decentralisation Scheme 'Involving Communities' (in terms
    of the Local Government Etc. (Scotland) Act 1994, to monitor the progress of
    the Scheme, and to make recommendations to Council on the nature of
    decentralisation in West Dunbartonshire and on any delegation of power.
  - Promote community involvement in partnership working and to consider matters relating to community involvement in partnership working in West Dunbartonshire.
  - Consider matters relating to Community Councils.
  - Consider matters relating to the Voluntary Sector.
  - Receive information about Council services, policies and associated business.

The Committee may make recommendations to Council or Committees on any, or all, of the above.

3.3 Regular evaluation of the Committee is needed to ensure it is fulfilling its role. The April meeting received a report outlining the outputs and outcomes of the

Committee over the last two years. Committee members were asked to refer to this information in making their evaluation responses.

#### 4. Main Issues

- 4.1 Separate evaluation questionnaires were issued to the community representatives and to the elected members sitting on this committee. A good response was received, with 19 community members out of a potential 25 completing questionnaires. No questionnaires were received from elected members.
- **4.2** The full evaluation responses are in Appendix 1. The majority of the feedback is positive. Below is a summary of the responses which tell us how the CPC is fulfilling its role:

## **4.3** Providing Information

The response to this was very positive with 17 (89%) finding the information 'useful' or 'very useful' and 2 (11%) 'fairly useful'. Comments include: 'Providing information is of great importance to us' and 'It is vital for effective community debate that this information is provided along with comment and discussion.'

### **4.4** Commenting on policies

An even more positive response was received for this with 18 (95%) finding the opportunity to comment on policies 'very useful' and 'useful' and 1 (5%) finding it 'fairly useful'. Comments include: 'Keeps us ahead of the game – gives us a platform to express our views on WDC policies' and 'would like to know if comments are listened to and influence decisions'.

### 4.5 Commenting on consultation mechanisms and arrangements

Again a positive response indicated 16 people (84%) agreed the opportunity to comment on consultation mechanisms and arrangements is 'very useful' or 'useful' and 3 (16%) thought it 'fairly useful'. Comments include: "Again not a lot of space for community organisations to have real in-depth input." "It allows us to comment on how the Council consults".

### **4.6** Opportunity to put items on the agenda

The majority of people agree that there is sufficient opportunity to put items on the CPC agenda (15 or 79%) with only one person disagreeing and three undecided. Comments include: "We have done so many times" and "Some seem to be on the agenda without being discussed for a long time (Not continuous updates). Others have been known to quietly fall off the agenda."

#### **4.7** Are you treated with respect?

The overwhelming majority agreed they are treated with respect (18 or 95%) with one person undecided. Comments include: "I think the Chair was very fair with all members of the Committee" and "I always feel like an equal member".

### **4.8** Do you get the opportunity to contribute to discussion?

The majority (15 or 79%) agree that they get the opportunity to contribute to discussion. Four people (21%) are undecided. Comments include: "There is fairness by Chair in ensuring each person at the table has the opportunity to contribute and "Not always – seems to be the same people commenting all the time".

4.9 Do you feel that community views, questions and issues are listened to?

There is a slightly lower agreement on this point with 13 (68%) agreeing and 6 (32%) undecided. Comments include: "Hopefully, but feedback on changes made because of CPC comments would be good" and "Listened to –yes. But perhaps not given enough serious consideration when debated in-house at a later date when final decisions are being taken".

## **4.10** Do community views expressed at the CPC have influence over decisions taken by Council?

13 (68%) people agreed the views expressed at the CPC have some influence (11) or a little influence (2), one person felt there is no influence and 5 (26%) are undecided. Comments include: "Really unsure. Maybe some feedback on how CPC has had influence in the past would be helpful in reassuring members that this happens." "Some things are fairly cut and dried but on some matters the administration has gone off to think again."

#### **4.11** Information and support to participate

The vast majority (18 or 95%) feel that they receive sufficient information and support to participate fully in the business of the Committee. One person doesn't feel there is enough support. Comments include: "Sometimes paperwork backing presentations could be improved – given out at the time of the presentation" and "The CPC administration is, in my opinion, the best of any Committee that I attend. The paperwork is of a very high quality and this contributes hugely to the effectiveness of the Committee".

## **4.12** Do you think the Community Membership of the CPC reflects the diversity of the community in West Dunbartonshire?

There was a mixed response to this with 11 (58%) saying yes, 4 (21%) saying no and 4 (21%) undecided. Suggestions on who should be included are: young people (x3), women (x2), Black and Minority Ethnic (x2) and LGBT (Lesbian, Gay, Bi-sexual and Transgender) (x4)". Disabled representation was suggested (currently represented via the West Dunbartonshire Access Panel).

In addition to these comments made directly on membership, representation was also raised in relation to other questions as follows:

Commenting on Policies - "But it is limited in terms of how representative the Committee actually is. Are oppressed groups like women and minorities represented proportionately and appropriately?"

The opportunity to contribute to the discussion of the agenda items - "The mainly white male composition ensures most time and space is taken up by them."

### **4.13** About community representatives' groups and role on the CPC

We asked six questions to find out how much the CPC features on community representatives' group agendas. The responses show that there is scope for representatives to be more proactive in their role, in particular on seeking agenda items for the CPC and items for the Community News standing item. (See the full table in Appendix 1).

## **4.14** Ideas for improving the CPC

There were some positive comments about the way the Committee currently works. Key points include:

- broaden the membership of the Committee (supported by points made at 3.12 on Committee membership)
- improve timescales to allow groups to contribute to the agenda
- circulate the CPC Newsletter electronically and
- include group updates in the CPC Newsletter.

## 7. Risk Analysis

7.1 The influence of CPC views on Council decision-making should be better evidenced. If this isn't achieved, there is a risk that the CPC will fail to fulfil its full role.

## 8. Equalities Impact Assessment (EIA)

- **8.1** An impact assessment has been carried out in relation to the evaluation feedback and equalities considerations are being taken into account by recommending follow up action on:
  - broadening membership and
  - the support requirements identified by one respondent.

To help raise awareness of equalities considerations, members of the committee can also take part in Equalities Awareness Training run by the Council.

#### 9. Consultation

- **9.1** The recommendations are based on the evaluation responses of community members of the committee who represent their wider groupings.
- 10. Strategic Assessment
- **10.1** The Community Participation Committee plays a role in gaining community views and supporting community activity. It informs all the strategic priorities by way of contributing to developing and improving services and policy making.

- It was sometimes dominated however by elected representatives who already have their own fora.
- To keep us up to date. Providing information is of great importance to us.
- Recycling arrangements work well but still feel kerbside glass recycling would improve the service greatly.
- It is vital for effective community debate that this information is provided along with comment and discussion.
- The information that is provided is very useful and allows us to see how the Council services work.

# 12. Finally, have you any Ideas for improving the CPC – including anything that would help you fulfil your role in relation to question 11?

- Membership could be broadened to ensure greater representativeness.
- My opinion is that the CPC works to its strengths.
- Time should be given for groups to be able to contribute to the agenda although groups are asked timescales do not always allow for contribution.
- We feel this is a good and worthwhile committee as it brings together representatives from other organisations and members of the Council.
- It was helpful to know how Council works and how the groups participate in
  decision making, if all the departments are working to their budgets etc. What
  are the future arrangements to improve the services and how they will be
  funded? The taxpayer funds are not wasted and checks and measures are in
  place? How it is necessary to cut some services to save the other services
  which are more important.
- As a substitute member I have seldom had a chance to participate fully. I intend to take this issue up with the main CC Forum member.
- A fully updated Community Directory as a point of reference.
- Circulate the CPC Newsletter to group secretaries electronically.
- It would be interesting if CPC members sent updates to be included in the CPC papers of what their groups are doing and how they discuss items from CPC committee.
- The community in general could do better with more general information in many aspects re the CPC.
