

## **WEST DUNBARTONSHIRE LICENSING BOARD**

At a Meeting of the West Dunbartonshire Licensing Board held in Committee Room 3, Council Offices, Garshake Road, Dumbarton on Tuesday, 17 June 2014 at 10.00 a.m.

**Present:** Councillors Jim Brown, Gail Casey, Michelle McGinty, Marie McNair\* and Hazel Sorrell.

### **APPOINTMENT OF CHAIR**

In accordance with Schedule 1, Section 6(5) of the Licensing (Scotland) Act 2005 and in the absence of the Convener, Councillor Mooney, the Board agreed to elect another of its members to chair the meeting.

Thereafter, the Board agreed that Councillor Michelle McGinty be appointed to chair the meeting and accordingly Councillor McGinty assumed the Chair.

### **DECLARATIONS OF INTEREST**

Councillors Casey, McNair and Sorrell declared a non-financial interest in the items of business entitled 'Application for Provisional Premises Licence – Café on the Loch, The Gateway Centre, Ben Lomond Way, Loch Lomond Shores, Balloch' and 'Application for Provisional Premises Licence – 16 Castlehill Road, Dumbarton', being members of the West Dunbartonshire Community Health and Care Partnership, given that objections had been submitted in relation to the applications by a sub-group of the West Dunbartonshire Alcohol and Drug Partnership. All three Members intimated that they would remain in the meeting during consideration of the items of the business and would take part in any decisions reached by the Board.

## **MINUTES OF PREVIOUS MEETING**

The Minutes of Meeting of the Licensing Board held on Wednesday, 11 March 2014 and the Minutes of the Special Meeting of the Licensing Board held on Wednesday, 21 May 2014 were submitted and approved as correct records.

## **VARIATION IN THE ORDER OF BUSINESS**

Having heard the Chair, Councillor McGinty, it was agreed that the order of business be varied as hereinafter minuted.

## **REVIEW OF PERSONAL LICENCE – MS KELLY BRYCE**

In terms of Section 84(a)(2) of the Licensing (Scotland) Act 2005, Members were requested to hold a Hearing to consider the Personal Licence held by Ms Kelly Bryce.

It was noted:-

- (a) that both the licence holder and a representative of Police Scotland had been invited to attend the meeting in order that a Hearing could take place; and
- (b) that Ms Bryce had intimated in advance of the meeting that she was unable to attend.

## **DECIDED:-**

The Board agreed to continue the Review Hearing to the meeting of the Board scheduled to be held on Tuesday, 9 September 2014.

## **REVIEW OF PERSONAL LICENCE – MR OSMAN NASEEM**

In terms of Section 84(a)(2) of the Licensing (Scotland) Act 2005, Members were requested to hold a Hearing to consider the Personal Licence held by Mr Osman Naseem.

It was noted:-

- (a) that both the licence holder and a representative of Police Scotland had been invited to attend the meeting in order that a Hearing could take place; and
- (b) that Mr Naseem was not in attendance at the meeting; and
- (c) that Sergeant David Quinn, Licensing Sergeant was in attendance of behalf of the Chief Constable, Police Scotland.

**DECIDED:-**

The Board then heard from Sergeant Quinn who formally withdrawn the letter from the Chief Constable seeking a review of Mr Naseem's Personal Licence.

**APPLICATION FOR PROVISIONAL PREMISES LICENCE IN TERMS OF THE  
LICENSING (SCOTLAND) ACT 2005**

An application for a Provisional Premises Licence was submitted for the Café on the Loch, the Gateway Centre, Ben Lomond Way, Loch Lomond Shores, Balloch G83 8QL.

Mr Archie Maciver, Brunton Millar Solicitors, accompanied by a representative of the applicant, Mrs Lorraine Cadona, was heard on behalf of the applicant. It was noted that the application was amended so that the terminal hour for sale of alcohol for both on sales and off sales at the premises would be 6.00 p.m. and that any proposed functions would be dealt with by way of Extended Hours Application.

In view of the letter of objection from West Dunbartonshire Community Health & Care Partnership, Ms Helen Weir, Strategy Manager, Alcohol and Drug Partnership Lead was heard in relation to the objection submitted.

**DECIDED:-**

Following consideration of all matters before the Board, it was agreed that the amended application be granted.

**APPLICATION FOR PROVISIONAL PREMISES LICENCE IN TERMS OF THE  
LICENSING (SCOTLAND) ACT 2005**

An application for a Provisional Premises Licence was submitted in respect of 16 Castlehill Road, Dumbarton G82 5BL.

Mr John Gilmour, McArthur Stanton Solicitors, accompanied by Mr Haq, Clyde Lets Limited, was heard on behalf of the licence holder.

In view of the letter of representation from West Dunbartonshire Community Health & Care Partnership, Mrs Helen Weir, Strategy Manager, Alcohol and Drug Partnership Lead was heard in relation to the objection submitted.

Ms Ann Louise Crawford and Mrs Elizabeth McCafferty were then heard in relation to the letter of objection and accompanying signed petition submitted on behalf of residents of Castlehill and surrounding areas.

With the consent of the Board, it was agreed that a late objection from Councillor David McBride would be taken into consideration. Thereafter, Councillor McBride's objection was circulated to members of the Board and the applicant. Councillor McBride, who was in attendance at the meeting for this item of business, was heard in relation to his objection.

Mr Martin Hollern, a local resident, was then heard in support of the application.

**REVIEW OF PERSONAL LICENCE CONTINUED

With reference to the Minutes of Meetings of the Licensing Board held on 11 March 2014, 17 December 2013 and 17 September 2013 and in terms of Section 84(3)(a) of the Licensing (Scotland) Act 2005, a report was submitted by the Clerk to the Licensing Board providing information to assist the Board in considering the Review of the Personal Licence held by Mr Calvert given the findings of the Licensing Board

that Mr Calvert's conduct had been inconsistent with the licensing objectives of preventing crime and disorder, securing public safety and preventing public nuisance.

## **EXTENSIONS TO LICENSING HOURS OVER THE FESTIVE PERIOD**

A report was submitted by the Clerk to the Licensing Board proposing a policy on the granting of Applications for Extended Hours over the 2014/2015 Festive Period in terms of Section 68 of the Licensing (Scotland) Act 2005.

### **DECIDED:-**

- (1) that the period for granting applications for extended hours in respect of the 2014/2015 Festive Period should be from Monday, 1 December 2014 to Thursday, 1 January 2015;
- (2) that application for extended hours for the festive period from all holders of premises licences be permitted for the dates and hours as detailed in table 1 of the appendix to the report;
- (3) that applications for extended hours for the festive period be available to those holders of premises licences who have a separate function room in their premises and have planned functions booked during the dates and hours as per table 2 in the appendix to the report. These extensions being only permitted in respect of the separate function rooms where appropriate festively themed entertainment is provided;
- (4) that premises licence holders without significant entertainment (public houses, hotel bars and members' clubs fall into this category) may apply for extended hours to 3.00 a.m. on Hogmanay on condition that last entry to the premises is 11.00 p.m. and the event is pre-ticketed;
- (5) that authority for the granting of applications for extensions to licensing hours over the Festive Period be delegated to the Clerk to the Licensing Board, if in accordance with the foregoing agreed recommendations;
- (6) that should applications for extended hours be submitted which fall outwith the agreed hours, or aforementioned recommendations, then any such applications will require to be submitted to the Board for consideration; and
- (7) that approval of any late applications for festive extensions would be delegated to the Clerk to the Licensing Board in consultation with the Chair of the Licensing Board.
