LETTING -SCHEME OF CONCESSIONARY DISCOUNTS

The discount schemes listed below relate to educational establishments generally. However those establishments listed in Appendix 1 are subject to the minimum charges stated within Appendix 2.

Category A. (100% Discount)

- 1. Playgroups/Play schemes operating in schools that are non-profit making for routine activities and where no additional janitorial cover is required.
- 2. West Dunbartonshire Sports Council and Soccer Council Meeting (in designated facilities).
- **3.** Parent Council/PA/PTA and School Activities (in designated facilities provided they finish before 11.00pm, thereafter to be charged at the full rate).
- **4.** Board/PA/PTA sponsored extra curricular activities (e.g. concerts until 11.00pm in designated facilities, thereafter to be School charged at the full rate).
- 5. All School Board/PA/PTA business meetings (in designated facilities).
- 6. Councillors Surgeries/Community Consultation non-political meetings.
- **7.** Community Education Centre membership groups, 2 business meetings per year in designated Educational facilities.
- **8.** Organisations applying for a single let which, in the opinion of the Council make significant contribution to the community of West Dunbartonshire.
- **9.** Senior Citizen groups for routine weekly activities and established annual events. (Where the establishment is already open).
- **10.** Youth and Voluntary organisations registered with the Community Education Service for routine activities (in Educational Services facilities where the establishment is already open).
- **11.** Alcoholics Anonymous.

Note: A let requiring a liquor licence for the specific purpose of fund-raising for the school in question would be granted a free let on the first occasion but any subsequent let of the same nature would be granted at 25% discount on the full charge

Category B. (75% Discount)

- 1. Local Gala Committees. (One let per week maximum 4 hours)
- 2. Senior Citizens groups for routine weekly activities and established annual events.
- 3. Special Needs groups for routine weekly activities and established annual events.
- **4.** Youth and Voluntary organisations, registered with the Community Education Service, for routine activities (Educational Services facilities)
- **5.** All activities run by Statutory Education Authority Youth Clubs and the Sports/Arts Development Officer (in Educational Services facilities).
- 6. Non-profit making Playgroups and Play schemes operating in schools for routine activities (where additional janitorial cover is required).
- 7. Festival Committee (in designated facilities)

Category C. (50% Discount)

- **1.** Regular non-profit making lets where a minimum of 10 consecutive weekly bookings are made and used.
- 2. Charitable organisations on production of details of charitable status.
- **3.** Residents/Tenants Associations for routine meetings.
- **4.** Community Councils' Association and decentralisation committees (including neighbourhood forums).
- 5. Church Services (full cost except where part of the School Area letting plan).
- 6. Sunday Schools (full cost except where part of the School Area letting plan).
- **7.** Fund raising activities for community groups and organisations (in designated facilities).

Full Costs apply to all commercial trading and profit making lets. Note

- Certain facilities are not available at all times. Please check availability before submitting a booking form or making any other organisational arrangements.
- This policy normally applies to West Dunbartonshire based groups only.
- The Council reserves the right to refuse any application for let or for an application for reduced let under this policy.
- The Authority reserves the right to offer a room larger than that requested or several rooms totalling the capacity requested and to apply such a lower rate as would have been due.
- Changing facilities are not included with those pitches attached to schools. If these facilities are required, additional charges are available on request.
- Figures in brackets show the minimum hourly rate chargeable after any concessionary discount.
- Out with normal opening hours **and** where an establishment is not already open, a minimum additional charge of £10.00 per hour will apply.
- The Authority reserves the right to offer a room larger than that requested or several rooms totalling the capacity requested and to apply such lower rate as would have been due.
- Lets for a part hour will be charged at the hourly rate.
- Pitch charges are made per game not exceeding 2.5hours.
- V.A.T may be charged for certain categories of let i.e. one-off football game.
