## Subject: Integrated Inspection by the Care Commission and HM Inspectorate of Education: Report on Follow-Through Inspection of Linnvale Early Education and Childcare Centre

## 1. Purpose

**1.1** To inform Members of the Committee of the Follow-Through Inspection of Linnvale Early Education and Childcare Centre carried out by West Dunbartonshire Council Quality Improvement Service, and of the report published in March 2010, which is attached as Appendix 1.

## 2. Background

- **2.1** Following the Integrated Inspection in September 2007, the nursery prepared an Action Plan in discussion with West Dunbartonshire Council. The main points for action were as follows:
  - The Head of Centre should develop formal systems for monitoring children's experiences and progress;
  - The Head of Centre and staff should ensure effective transitions for children moving onto primary school.
- **2.2** The Quality Improvement Service visited the nursery to assess the extent to which the nursery was continuing to improve the quality of its work and more specifically to respond to the main points for action in the original Inspection Report.

#### 3. Main Issues

- **3.1** Members will note that very good progress has been made in relation to both main points for action.
- **3.2** Overall the Quality Improvement Service was satisfied that the nursery had made very good progress in all areas of learning and teaching under the high quality leadership of the Head of Centre. They conclude that the Centre is very well placed to sustain and build on the improvements that they have achieved to date.

# 4. People Implications

**4.1** This report has no specific implications for Personnel. It should be noted however that the Head of Centre has now left post to take up employment in another local authority area. The post is currently filled on a temporary basis. Decisions regarding the permanent appointment to this post are dependent on decisions being taken in relation to the wider restructuring of the Early Years and Childcare Service.
