Subject: Summary of Voluntary Grants 2006/2007

1. Purpose

1.1 The purpose of this report is to provide an analysis of voluntary grants approved during 2006/07.

2. Background

- 2.1 The Corporate Services Committee in March 2007 approved changes to the voluntary grants procedures. Within the approved changes, it was agreed that a report be brought to Committee after the year end giving additional information regarding analysis of the grants approved during the financial year.
- **2.2** Some of the information likely to be provided in future years has not historically been asked for through the grants process such as grant application by ward, deprivation area, Council priority, etc. During the grants process for 2007/08, this information will be requested and reported on in 2008. However, for 2006/07 grants the information is limited to the information available within the previous application forms.

3. Main Issues

- **3.1** From the 2006/07 budget, grants applications totalling £0.641m were paid. This excludes grants paid out to old people's welfare organisations at Christmas and those paid to community councils.
- 3.2 Appendix 1 analyses these grants by different categories:-
 - (a) By awarding department 68% of grant funding was awarded through recommendations made by Corporate Finance, with 8% by Education and 24% by Social Work.
 - (b) By value of award There were 105 grants paid through the grants budget - 30% of these were awarded to organisations receiving grants over £5,000 (32 grants, worth £0.514m), 57% to organisations receiving grants between £500 and £4,999 (59 grants, worth £0.122m) and the remaining 13% for grants of less than £500 (14 organisations, worth £0.005m)
 - (c) By reason the majority of grant funding (77%, equivalent to £0.494m) is used by organisations for running costs, with smaller sums being used for the purchase of equipment (7%, equivalent to £0.045m), one-off or annual events (6%, equivalent to £0.038m) and the remainder on repairs, travel and ad hoc costs.

(d) By group type – the majority of the funding is used by advice groups (59% - £0.382m), for sports groups (18% - £0.116m) and for children's groups (10% - £0.062m). The remainder being used for elderly groups and entertainments groups.

4. Financial implications

4.1 There are no financial implications.

5. Personnel Issues

5.1 There are no personnel issues.

6. Risk Analysis

6.1 No risk analysis was required.

7. Conclusions

- **7.1** Analysis suggested that grants awarded to voluntary organisations by the Council are used in a variety of ways to help the local community and vary greatly in amount.
- **7.2** With additional information being requested through the newly introduced grants procedures, further analysis will be reported to Members on the grants awarded during 2007/8.

8. Recommendations

8.1 The Committee is invited to note the report.
