# Provost Macdonald in the Chair

#### **PROVOST'S REMARKS**

<sup>3975</sup> Provost Macdonald welcomed Chief Superintendent Rogers, Sergeant Armour and Mr McKendrick to the meeting.

#### RESULTS OF BY-ELECTION WARD 11 (BOWLING/MILTON/OLD KILPATRICK)

- <sup>3976</sup> A report was submitted by the Returning Officer informing the Council of the results of the Local Government By-election for Ward 11 Bowling/Milton/Old Kilpatrick, which was held on 14 October 2004.
- <sup>3977</sup> After hearing Provost Macdonald, the Council agreed to note that George Black (Independent) had been elected to serve in Ward 11 Bowling/Milton/Old Kilpatrick.

## ANTI-SOCIAL BEHAVIOUR

#### (a) **Presentation**

- 3978 Sergeant Armour, Liaison Officer, Strathclyde Police and Mr McKendrick, Team Leader (Assist Team) gave a joint presentation on the implications of Sections 1 - 4 and 6 of the Anti-Social Behaviour (Scotland) Act 2004, which would come into effect on 28 October 2004.
- Having heard Chief Superintendent Rogers and the Chief Executive in answer to Members' questions, the Provost on behalf of the Council, thanked Sergeant Armour and Mr McKendrick for their very informative and interesting presentation.

#### (b) Anti-Social Behaviour (Scotland) Act 2004

- A report was submitted by the Director of Housing and Technical Services providing an update on legislative changes introduced under the Anti-Social Behaviour (Scotland) Act 2004.
- <sup>3981</sup> Having heard Mr McKendrick in answer to Members' questions, the Council agreed to note the report. Thereafter Mr McKendrick left the meeting.

# **OPEN FORUM**

#### Donald McDonald, 36 North Elgin Street, Whitecrook New Community Schools – Braidfield High School

<sup>3982</sup> In 1998, West Dunbartonshire Council was awarded considerable funding by the Scottish Executive to implement their vision of New Community Schools. In their wisdom, the Council chose Braidfield High School as the flagship for this venture. The lion's share of available funding was channelled into Braidfield, while other schools in the region were virtually neglected by comparison.

- <sup>3983</sup> However, over the next 6 years, while the less privileged schools continued to flourish, Braidfield High School was not transformed into a magnet school for the area; nor was the attainment level of pupils dramatically improved. Indeed, at the time of writing this question, it would seem that the flagship is about to be scuttled.
- <sup>3984</sup> Does the Council have a rational explanation for this unmitigated disaster?

#### Councillor Rooney responded in the following terms:-

- <sup>3985</sup> Thank you Provost, in the absence of Councillor McCallum I will respond to Mr McDonald's question.
- <sup>3986</sup> Firstly, I would like to thank Mr McDonald for submitting his question.
- <sup>3987</sup> The Scottish Executive's New Community School initiative was launched in 1999 to address social exclusion and raise attainment. Phase 1 of the initiative provided each Council in Scotland with £200,000 per annum for 3 years to establish one New Community School Pilot Project.
- <sup>3988</sup> Braidfield was selected as West Dunbartonshire's Phase 1 pilot as it most closely met the criteria. The pilot projects were selected on the basis of deprivation indicators, attainment levels, local needs and local circumstances.
- <sup>3989</sup> Taking account of socio-economic, demographic and other factors which impact on attainment and social exclusion, West Dunbartonshire Council envisages that it would take from 10 years to a generation before the goals of Integrated Community Schools would be realised. This is a factor which has been endorsed in the Scottish Executive's National Evaluation of the Phase 1 Pilot Programme, and in the recent HMIE review of the eight Integrated Community School clusters.
- <sup>3990</sup> HMIE inspections of West Dunbartonshire Council, Braidfield and other schools and the recent inspection of Community Learning and Development in South Clydebank provided evidence of the effectiveness of the Council's achievements. Schools, partner agencies and the Council can be justifiably proud of the progress to date.
- 3991 Scottish Executive funding is no longer linked to individual projects and the Scottish Executive requires all schools in Scotland to embrace the principles of integrated community schools by 2006/2007. The structures and strategies for achieving this are already well-established in West Dunbartonshire.
- <sup>3992</sup> West Dunbartonshire Council was one of the first Authorities in Scotland to roll out the model across all its schools and school clusters from 2000/2001. We are committed to the principles that underpin New Community Schools, and to ensuring that all schools and school clusters would benefit from the additional funding.

<sup>3993</sup> This ambitious long-term goal is reflected in West Dunbartonshire Council's vision as a Community Authority. Again I repeat schools, partner agencies and the Council can be justifiably proud of the progress to date.

#### Mr McDonald asked the following supplementary question:-

<sup>3994</sup> Councillor Rooney made no mention of the unmitigated disaster in his response. Since the Braidfield High School pilot has been a resounding failure and, best practice suggests that community schools with educational learning centres etc, are therefore not the best way to ensure improved educational achievement and standards, will West Dunbartonshire Council admit that the community school strategy has been disastrous and therefore its future plans to decimate our schools and create super schools with community centres could also result in disaster? Also, if after the consultation with parents on the proposed closure of schools, will the Council consider a number of proposals, and I mean proposals in plural, not a single proposal, when deciding on their future?

# At the request of Councillor Rooney, the Director of Education and Cultural Services responded as follows:-

- <sup>3995</sup> The questioner appears to be referring to two separate areas in talking of "the decimation of our schools" and the alleged "disaster" of new Community Schools initiative.
- <sup>3996</sup> The new community schools initiative, of which the Council is justly proud, was piloted in Braidfield High School and subsequently rolled out across the authority.
- <sup>3997</sup> The questioner, in mentioning school closures, seems to be referring to the schools' regeneration programme, that is, the bid which resulted in this Council being awarded the sum of £100m. The £100m funding represents more than £1000 for every pupil in West Dunbartonshire, by far the highest sum per capita awarded to any Scottish Council.
- <sup>3998</sup> In relation to the description of Braidfield High School as an unmitigated disaster, this would hardly accord with the views expressed at the public consultation meetings on the closure of Braidfield High School, when those present spoke with pride about the school. The reason the closure of the school was proposed had nothing to do with the school being "a disaster" and was related totally to the fact that the pupil roll had fallen to the point at which it becomes educationally disadvantageous to keep the school open. Far from the school being an unmitigated disaster we have been at pains to stress that no blame attaches to pupils, parents, teachers or the school community. Quite simply, the roll has fallen to the point where is makes more sense to close the school.

#### Mr Lockhart H. Cameron, 13f Howcraigs Court, Clydebank Policy on Council employees campaigning during normal working hours

<sup>3999</sup> What is West Dunbartonshire Council's policy in relation to council employees campaigning during normal working hours on behalf of a political party candidate?

#### Councillor Bootland responded in the following terms:-

<sup>4000</sup> The Council's policy on Politically Restricted Posts applies to our employees campaigning at Elections. Within the terms of this Policy it is possible for employees to campaign during normal working hours if they hold a post which is not politically restricted and are using their own time (such as authorised annual leave).

#### Mr Cameron asked the following supplementary question:-

4001 Can West Dunbartonshire Council confirm that no employee was paid by the Council when campaigning on behalf of a political party during the recent byelection.

# At the request of Councillor Bootland, the Director of Corporate Services responded as follows:-

<sup>4002</sup> It is possible that an employee, who campaigned on behalf of a political party in his/her own time i.e. on authorised leave, could be paid by the Council.

- <sup>4003</sup> The Minutes of Meeting of West Dunbartonshire Council held on 29 September 2004 were submitted for approval.

- 4020 That the response be approved subject to the following amendments:-

#### Page 70, Question 8

4021 The response should be amended to include an option whereby people on benefits, for example the elderly, would be able to access grant assistance to help them meet these costs.

#### Page 72, Question 21

4022 The answer should be amended to read 'No'.

- <sup>4023</sup> The Director of Development and Environmental Services was heard in clarification of the availability of home improvement grants to people who are eligible to receive social security benefits.
- 4024 On a vote being taken, 5 Members voted for the amendment and 12 for the motion which was accordingly declared carried.

### (2) Paying for Water Services 2006-2010

- <sup>4025</sup> In terms of the remit from the Meeting of the Community Safety and Environmental Services Committee held on 6 October 2004 (Page 1162, paragraph 3905 refers), the relevant excerpt minute and report were submitted by the Director of Corporate Services recommending the Council's formal response to the Scottish Executive's consultation paper on the principles of charging for water services entitled "Paying for Water Services 2006-2010".
- 4026 Councillor O'Sullivan, seconded by Councillor Flynn, moved:-
- 4027 This Council welcomes the report and accepts the recommendation contained in paragraph 4.1 on Page 80 of the agenda with the following amendments:-

Consultation Point 2

- 4028 Delete "Not applicable" and insert:-
- This Council takes the view that any charging scheme should be based on a broad definition of Social Justice. The Scottish Executive should look at a division between domestic consumption, and other public good usages, and industrial or commercial consumption. Treating water as a commodity may be appropriate in the commercial and industrial field, but the market mechanism unfairly burdens the poorest in our society by making the charge for water take a significant proportion of their income. It would therefore, be appropriate to include an option of general taxation funding for the non-commercial sector.

Consultation Point 4

- 4030 After "Homes" on the second line delete all and insert:-
- The Council is concerned that the proposed withdrawal of discounts to single adult households may adversely affect both lone parent and single pensioner households. The Council will support any scheme of assistance that is based on the ability to pay as exists with the current Council Tax Benefit System. Whatever the scheme proposes, it should take into account the relative difference between lower and higher income households which would deliver a fairer, more efficient scheme of assistance to low income households.

- 4032 As an amendment, Councillor Black, seconded by Councillor Bollan, moved:-
- <sup>4033</sup> That, in addition to the amendments contained in the above motion, the following wording be added to the end of bullet point one (Consultation Point 1):-
- <sup>4034</sup> "providing all profits are reinvested in the public water system".
- 4035 On a vote being taken, 5 Members voted for the amendment and 12 for the motion, which was accordingly declared carried.

- <sup>4039</sup> Having heard Councillor Devine in further explanation, the Council agreed that the payment method detailed in Option 1 of the report be implemented this Christmas but that the payment method detailed in Option 2 of the report be phased in over the following three years.

- That the position of Chairman of the Licensing Board should not be given a responsibility allowance as there are sufficient numbers of responsibility payments being made to members of the Administration at present. Furthermore, there is sufficient scope within the existing scheme for someone, who currently receives a responsibility allowance but does not chair another committee, to chair the Board.
- 4051 On a vote being taken, 2 Members voted for the amendment and 14 for the motion which was accordingly declared carried.

- 4070 The paragraph in the column headed "What will we do" could lead to one Councillor being disadvantaged over another and therefore clarification is required prior to implementation.
  - (2) That, in relation to paragraphs 4 and 5 of the report, the financial and personnel implications of the Improvement Plan, should be reported back to Council and not the Social Justice Committee.
  - (3) That the Council should make the Minister for Communities aware of its concerns over the appeals mechanism for dealing with appeals against Communities Scotland's assessments (paragraph 2.4 and 2.5 of the report refer), as the second stage appeal was to the Regulation Board of Communities Scotland and is therefore not an independent body (in effect creating a Kangaroo Court).

- <sup>4073</sup> The Council agreed that Councillor Margaret McGregor be nominated to serve on the Board of the West Dunbartonshire Environment Trust.

- <sup>4075</sup> In accordance with Standing Order 8, the Council considered the undernoted motion submitted by Councillor Bollan:-
- <sup>4076</sup> In view of the widespread concern at recent events, this Council agrees it is wholly incompatible to be a sitting Councillor and to seek to secure commercial contracts with WDC.
- This Council therefore introduces a policy whereby any sitting Councillor is barred from seeking to secure commercial contracts from WDC until a two year period has elapsed from the end of the term of their office.
- <sup>4078</sup> Having heard Councillor Bollan in further explanation and the Head of Legal and Administrative Services confirm that the motion could not be legally enforced, Councillor Black seconded the above motion.
- <sup>4079</sup> As an amendment, Councillor Agnew, seconded by Councillor Duffy, moved that the motion be noted and no action taken.
- 4080 On an vote being taken, 11 Members voted for the amendment and 4 for the motion. The Amendment was accordingly declared carried.
