Subject: Grant Applications

1. Purpose

1.1 The purpose of this report is to provide updated information on a grant application to the Dumbarton Trust Fund and to make an officer recommendation for Members consideration.

2. Recommendations

2.1 It is recommended that Committee agrees the officer recommendation to award £3,822.96 requested in the grant application from Friends of Levengrove Park for the reasons provided within Appendix 1.

3. Background

- **3.1** The Trust Deed states that the purpose of the Dumbarton Trust Fund is for is for the benefit of the people of Dumbarton, to assist and relieve those in need by reason of age.
- **3.2** Dumbarton Trust Fund grants are administered by the West Dunbartonshire Council and are reported to the fund as and when applications are received.
- **3.3** Per the draft Financial Statements, the value of fund as at 31 March 2022 was £4,947.22. Since 31 March 2022 no grants have been awarded, therefore £4,947.22 remains available for distribution

4. Main Issues

Grant Applications

- **4.1** One application for grant funding has been received. Members should note that an amount of £3,822.96 is being recommended with full details being provided in the attached Appendix.
- **4.2** At a meeting held on 18th January 2023 after considering the grant application from Friends of Levengrove Park members decided to delay a

decision on awarding the grant until an update was available on the progress of the project since the committee awarded a previous grant to the same organisation on 22 October 2021.

- **4.3** The organisation has now advised the following update: The storage container and the trishaws were both ordered on 3rd February 2023. The trishaws are currently being held by Cycling Without Age Scotland while the storage container is delivered and installed. The lead in time for a storage container is 9 weeks, so this should be in place by mid-April.
- **4.2** Members will note the reasons provided by officers in relation to the recommendations of award and will need to ensure that when making Trust awards that these are made in line with the aims and purposes of the Trust Fund.

Subject: Depletion of Fund – Proposed Closure

1. Purpose

1.1 The purpose of this report is to provide information on the remaining balance in the Dumbarton Trust Fund and to recommend closure of the fund with the remaining balance to be distributed to Older People groups in the Dumbarton Area.

2. Recommendations

- **2.1** Members are asked to:
 - a) Approve the distribution of the remaining £1,124.26 in the Dumbarton Trust Fund to Older People Groups in the Dumbarton Area.
 - b) Consider whether there is a specific group, or groups, that they would wish to benefit from the distribution.
 - b) Approve the closure of the Dumbarton Trust Fund.

3. Background

- **3.1** The Trust Deed states that the purpose of the Dumbarton Trust Fund is for the benefit of the people of Dumbarton, to assist and relieve those in need by reason of age.
- **3.2** Dumbarton Trust Fund grants are administered by West Dunbartonshire Council and are reported to the fund as and when applications are received.
- **3.3** Per the draft Financial Statements, the value of fund as at 31 March 2022 was £4,947.22. A grant application for £3,822.96 is under consideration which if approved would reduce the remaining fund value to £1,124.26.

4. Main Issues

Proposed closure of Dumbarton trust Fund and redistribution of remaining funds.

- **4.1** One application for grant funding of £3,822.96 is being considered by the committee on 15 March 2023. Should this be approved the value remaining in the Trust Fund would reduce to £1,124.26.
- **4.2** As this fund is almost exhausted and applications for funding are extremely rare it is proposed that the remaining funds be distributed to Older People groups in the Dumbarton Area and the fund is closed.
- **4.3** Members of the Committee are asked to consider if there is a specific group, or groups, that they would wish to benefit from the distribution and, if applicable, the split each should receive.
