NOTES

1. The tender was advertised on Public Contracts Scotland. 17 notes of interest were recorded of which 7 made requests for tender documents. 6 out of this 7 submitted a tender
A pre-qualification questionnaire was included with the tender documents stating the minimum criteria required to undertake the contract. Only prices submitted by those meeting the minimum criteria were considered.
2. Three of the six tenders submitted were found to be compliant. These have been checked arithmetically and represent good value by current pricing levels; adjustments have been made where appropriate in accordance with the code of tendering procedures. It should be noted that the project has been tendered on the basis of a schedule of rates. The reported amounts are notional values only based on provisional quantities.
3. The following contractors were invited to tender but declined:- T tag Scaffolding
4. The date of lodgement of tenders was 23rd August 2010
5. The date of expiry of tenders is 22nd November 2010
6. The Head of Finance (Dept. of Corporate Services) has been consulted in accordance with financial regulations.
7. The notional tender project cost of £143,700.00 can be funded from the 'work by contractors' budget line in the Housing Maintenance trading account. It is anticipated that actual expenditure will exceed that of the notional tender amount.
8. A Pre-Construction Information Pack relating to the CDM Regulations was not required for this project.
9. The Chief Executive Officer and the Executive Director of Housing, Environmental and Economic Development are in agreement with this report.

It is recommended that the Tender of Clyde Scaffolding be selected as the lowest Tender for the Authority and be approved by the Members of the Tendering Committee.
