### Subject: Presentation by Head Teacher of the Vale of Leven Academy on measures taken to promote and raise attainment and achievement for pupils

#### 1. Purpose

**1.1** To provide Members with information on the work of the Vale of Leven Academy in taking forward attainment and achievement for all pupils.

### 2. Background

2.1 Members requested at an earlier meeting in November 2005 that each Secondary headteacher should give a presentation on attainment and achievement and the measures and strategies taken to build on strengths and develop areas for improvement.

#### 3. Main Issues

- **3.1** The presentation by the headteacher will show that improvements in tracking and raised expectations have had a positive impact on attainment through e.g: analysis of SQA data; self-evaluation of aspects of learning and teaching; monitoring calendars which include classroom visits and cross marking; rigorous monitoring of 'underachievers'; pupils being set agreed attainment targets; targeted mentoring.
- **3.2** There is a commitment to active engagement and communication with parents, pupils and staff in a variety of ways including newsletters, pupil reports, information evenings and the more formal structures of the school board and pupil council.
- **3.3** The school also operates a fully inclusive policy in relation to additional support needs.
- **3.4** The headteacher will also explain in his presentation how the school uses all resources effectively and efficiently including finance, personnel, materials and accommodation.
- **3.5** The following is an overview of SQA results in the last four years in relation to the % S4 roll.
