Creating the New CHCP - Project Plan Review

### **Recommendation**

The CHCP Committee is recommended;

- 1 to note the progress made in moving towards the creation of the new CHCP as set out in the attached update to the Project Plan; and
- 2 to agree that the Director brings forward to the first meeting of the full CHCP Committee a new Project Plan for the first 6 months of the new Partnership against which progress can be assessed and measured.

## **Background**

The report presented to the Council in February 2010 included a range of detailed items that required to be taken forward in the interim period to create the new CHCP.

This detailed list was subsequently supplemented, after discussion with NHS Board officers, to form a Project Plan that the lead officers from the Council and the Board would use to direct their activity during the shadow period.

#### **Discussion**

The Project Plan has now been updated to reflect the position as at the end of July 2010. Members will see that good progress has been made on all the elements that are required.

#### Next Steps

The Project Plan has been a useful tool in ensuring that progress to create the new CHCP from 1st October has been made. I now propose to develop and extend the Project Plan to set out the implementation priorities and objectives for the Partnership for the next six months.
