**Community Participation Committee: Wednesday 24 January, 2007**

**Subject: Community Participation Committee (CPC)- Involving Young People Event**

### **1. Purpose**

- 1.1** To report to the Committee on the above event and suggest future action.

### **2. Background**

- 2.1** The CPC is looking at ways of involving young people in Council decision-making. This event was planned jointly by young people with input from a community representative from the CPC, the Convenor of the CPC and officers of the Council. The purpose is to promote links with young people and help to identify ways of involving them.

### **3. Main Issues**

- 3.1** The event which took place on Tuesday 5 December brought together young people from youth forums in West Dunbartonshire with community representatives and elected members from the Community Participation Committee. The event was structured and led by the young people.
- 3.2** An introductions session heard from one of the young people about his involvement in the local youth forum, from the Convenor of the CPC on why she became a councillor and from the Gingerbread community representative about how she became involved in her community in a range of ways.
- 3.3** The company then broke into two groups (young people in one group and Community Participation Members in another) to discuss the things they liked about their community and the things they would like to change.
- 3.4** Following this, there was open discussion about the things people had identified about their communities, with a number of common areas emerging including:
- Liking for local shops
  - Liking for college
  - Interest in the history and heritage of West Dunbartonshire

- Dislike of drug and alcohol abuse, vandalism, arson and crime in general
- Concerns about groups of young people 'hanging about'– with different perspectives from the young people and adults present.

The full list of subjects raised is attached as Appendix 1.

There was lively discussion and a good exchange of views and ideas, with contributions from most of the participants.

#### **4. Personnel Issues**

**4.1** There are no personnel issues.

#### **5. Financial Implications**

**5.1** The costs of the event were met within existing budgets.

#### **6. Conclusions**

**6.1** Bringing together young people and members of the CPC raised awareness of the committee's role. The next steps will be to consider how we can continue to develop links with young people. Some of the issues identified may provide the basis for future events or presentations.

#### **7. Recommendations**

**7.1** The committee is invited to consider the contents of this report and, in particular, to consider planning a future event around one or more of the themes raised above at 3.4 and in Appendix 1.
