Subject: Affiliations

1. Purpose

1.1 To inform the Council of those organisations to which the Council has been affiliated in previous years and to seek approval to renew the affiliations on an annual basis.

2. Background

2.1 In previous years, West Dunbartonshire Council has received correspondence from a number of organisations seeking affiliation. The Council is currently affiliated to a number of organisations and it is therefore appropriate that the list of affiliations be reviewed at this time.

3. Main Issues

- 3.1 A list of those organisations to which the Council is affiliated together with a note of the annual affiliation fees is shown in the Appendix to this report. Members are asked to note that these fees normally increase by inflation on an annual basis. It should also be noted that the list does not refer to COSLA, as the Council has already agreed to affiliate to this organisation at a previous meeting. In addition, the list does not include any affiliations to professional bodies to which relevant professional services of the Council have affiliated and are therefore funded by departmental budgets, e.g. CIPFA (Chartered Institute of Public Finance and Accountancy).
- 3.2 The Council is also asked to consider whether it wishes to nominate an Elected Member to serve on the Executive Committee of the Scottish National Federation for the Welfare of the Blind and the Nuclear Free Local Authorities (Scotland). The Scottish National Federation for the Welfare of the Blind has confirmed that it would be acceptable for an officer to attend its meetings in place of an Elected Member.
- 3.3 It is likely that the Council will continue to receive further requests from external organisations seeking affiliation. In order to reduce the workload of the Council, it is suggested that all future affiliation requests should be referred to the Corporate and Efficient Governance Committee for consideration.

4. Personnel Issues

4.1 There are no personnel issues.

5. Financial Implications

5.1 The Council is currently affiliated to all of the organisations listed in the Appendix to the report and therefore provision has been made for this expenditure within the Council's revenue budgets.

6. Risk Analysis

6.1 There is no requirement to undertake a risk assessment in relation to the recommendations of this report.

7. Conclusions

7.1 Given the change in political leadership of the Council, it is appropriate that the list of affiliations be reviewed at this time.

8. Recommendations

- **8.1** The Council is asked:-
 - (a) to consider whether it wishes to continue its affiliation to all of the organisations shown in the Appendix to this report and authorise officers to renew the annual membership fees, as and when required;
 - (b) to consider whether it wishes to nominate an Elected Member or an officer to serve on the Scottish National Federation for the Welfare of the Blind and an Elected Member to serve on the Nuclear Free Local Authorities (Scotland); and
 - (c) to agree that all future affiliation requests be referred to the Corporate and Efficient Governance Committee for consideration.
