Subject: Monitoring Scottish Executive Statutory Returns

1. Purpose

- 1.1** The purpose of this report is to inform Members of the results of monitoring Scottish Executive statutory returns for the period 1 April 2005 to 31 March 2006.

2. Background

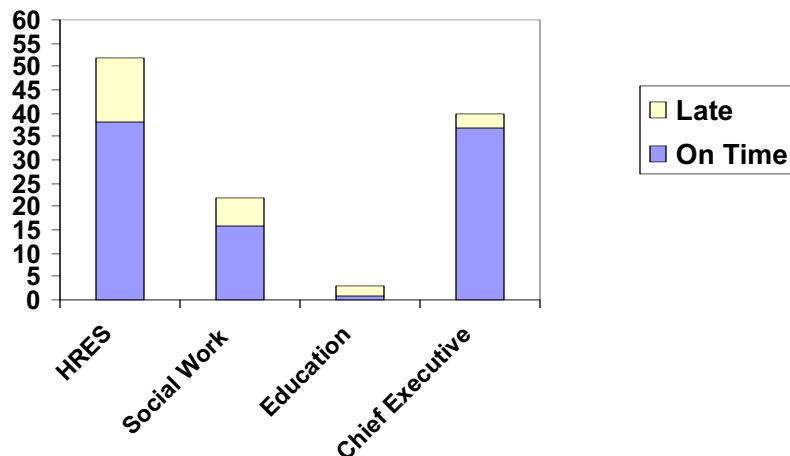
- 2.1** Local authorities are obliged under Section 199 of the Local Government (Scotland) Act 1973 to provide certain information to the Scottish Executive. Much of this information takes the form of regular statistical returns.
- 2.2** At the Executive meeting of 13 December 2000 it was agreed to report the Scottish Executive Statutory Returns annually, at the end of each financial year.

3. Main Issues

Results of Monitoring Scottish Executive Statutory Returns 1 April 2005 to 31 March 2006

- 3.1** Of the 117 returns requested by the Scottish Executive relating to the financial year 1 April 2005 and 31 March 2006, 79% (92) were returned by the due dates with 21% (25) returned late. There has been a steady improvement in the performance over the last 3 years as 75% were returned by the due date in 2004/05 and only 67% were returned on time in 2003/04.
- 3.2** Figure 1 on the following page examines this in more detail, looking at the responses of individual services.

more detail comparing it with 2004/05 returns which are detailed in brackets. It highlights that 15 (60%) of the 25 returns submitted late were forwarded within 4 weeks or less.

- 3.4** There were 10 returns submitted more than 4 weeks after the due date.
- 3.5** The return submitted more than 4 weeks late from the Chief Executive's was due to long term sickness of key personnel.
- 3.6** Social Work Services submitted 3 out of 22 returns more than 4 weeks late. One of the late returns was due to a key member of the strategy team being on sick leave when the forms were distributed by the Scottish Executive which resulted in the initial delay in processing the return. The first of the other two, which are quarterly returns, was delayed due to financial and statistical not being available until the end of the first quarter and changes in personnel. This had a knock on effect on the submission of quarterly return due at the end of the second monitoring period.
- 3.7** Housing, Regeneration and Environmental Services submitted 6 out of 52 returns more than 4 weeks late. Five of the 6 were submitted late due to key personnel leaving the council. The sixth late return is monitored and returned by Building Services and the delay was due to priority being given to the introduction of the Building (Scotland) Act 2003.
