Subject: Cosla Staffing Watch Survey (December 2006)

1. Purpose

- 1.1** The purpose of this report is to advise Committee on the size of the Council's workforce as at 9 December 2006.

2. Background

- 2.1** All 32 Scottish Councils are required to complete staffing watch surveys at quarterly intervals. Returns are provided for the workforce composition as at March, June, September and December to CoSLA who collate the information at a national level.
- 2.2** The survey provides details on staffing levels, service areas, gender, numbers and F.T.E.'s for permanent or temporary and full-time/part-time working within Councils, within 6 service groups.

3. Main Issues

- 3.1** The survey report on the Council's workforce as at 9 December 2006 is shown at Appendix 1. The survey shows that the Council's workforce has increased by 109 employees compared to the same period in the previous year (December 2005). There has been a significant increase within Education (teachers and other staff) in comparison to the previous year, this was due to new posts being created for support staff. Number of teachers within a school are dependent on class sizes, and as class sizes have reduced this has meant an increase in the number of teachers.
- 3.2** The Council's workforce has increased by 7 employees from the previous quarter (Sept 2006).

4. Personnel Issues

- 4.1** There are no personnel issues.

5. Financial Implications

- 5.1** There are no financial implications, however increases in employee numbers will increase the Council's staffing budget.

6. Risk Analysis

- 6.1** This quarter's report indicates a small increase in staffing numbers compared to the previous quarter and no further risk analysis is necessary as the statistics show a normal trend throughout the year.

7. Conclusions

- 7.1** The Council's workforce has followed normal trends during the period.

8. Recommendations

- 8.1** The Committee is invited to note the contents of the report.
