MINUTES OF PREVIOUS MEETING

The Minutes of Meeting of the Audit & Performance Review Committee held on 12 November 2008 were submitted and approved as a correct record.

REVIEW OF PROGRESS IN ACTIONING RECOMMENDATIONS CONTAINED WITHIN INTERNAL AUDIT AND EXTERNAL AUDIT REPORTS

A report was submitted by the Chief Executive advising of the progress being made in actioning recommendations contained within key Internal Audit and External Audit reports which management has committed to implementing.

PERFORMANCE MANAGEMENT FRAMEWORK

A report was submitted by the Chief Executive proposing a modified performance management framework for the Council and covering several other issues relating to performance management such as the use of traffic lights to illustrate performance, the SOLACE 'Golden Thread' health check, the implementation of the Covalent system and the outcome of the Accounts Commission consultation on the Statutory Performance Indicators.

The Section Head, Performance Management, gave a brief demonstration of the performance information which was currently available to elected members and the public on the Council's website.

After hearing the Section Head, Performance Management, in further explanation and in answer to Members' questions, the Committee agreed:-

- (1) to note that a further report would be submitted to the Audit & Performance Review Committee in March 2009:
- (2) that a quick reference guide be sent to all elected members explaining how to access the performance information which is available on the website;
- (3) that officers should investigate the possibility of being able to record the number of hits on the performance web pages to assess the level of public interest in the facility; and
- (4) to note that the Council's newspaper, which features the Council's performance information on a regular basis, has been included in the savings options for the 2009/10 budget process and therefore, if this savings option was approved, then the Council would need to review how it makes performance information available to the public.
