Subject: Corporate Plan 2010/14 Year End Progress Report - Further information on those Pls assigned to Housing, Environmental and Economic Development which significantly missed their targets

1. Purpose

1.1 The purpose of this report is to provide further details on the Department's six performance indicators (PIs) in the Corporate Plan 2010/14 year end progress report which significantly missed their targets i.e. where the status was reported as red.

2. Background

- 2.1 The year end progress report on the Corporate Plan 2010/14 was submitted to the Audit & Performance Review Committee on 10 August 2011.
- **2.2** Following discussion at this Committee, all departments were asked to submit further details to their service committees on those PIs assigned to them which significantly missed their targets.
