APPLICATION FOR REVIEW: DC11/099/HOU

With reference to the Minutes of Meeting of the Local Review Body held on 1 November 2011 (Page 3957 refers), the LRB resumed consideration of review papers for Planning Application DC11/099/HOU - Proposed two storey extension to rear of property at 12 Islay Crescent, Old Kilpatrick.

Reference was also made to the recent site inspection which had taken place in connection with the application for review.

Following discussion, Members agreed that they now had sufficient information to enable them to determine the review.

Having heard the Chair and having considered all of the information before them, the LRB were of the opinion that the proposal was acceptable in terms of Policy H5 of the West Dunbartonshire Local Plan and that planning permission should be granted. Accordingly, the LRB agreed to reverse the determination of the appointed officer and to grant planning permission subject to the recommended conditions, as detailed in Appendix 1 hereto.

**APPLICATION FOR REVIEW CONSIDERED BY THE LOCAL REVIEW BODY ON

**Planning Application DC11/099/HOU – Proposed two storey extension to rear
of property at 12 Islay Crescent, Old Kilpatrick**

Permission GRANTED subject to the following conditions:-

1. The development hereby approved shall commence within a period of 3 years from the date of this decision notice.

Reason In accordance with the terms of Section 58 of the Town and Country Planning (Scotland) Act 1997 (as amended).

2. The developer shall submit to the Planning Authority in writing upon the forms specified for the purpose and attached to this decision notice:
 - (a) A Notice of Commencement of Development as soon as practicable once it is decided to commence the development hereby approved (which shall be prior to the development commencing); and
 - (b) A Notice of Completion of Development as soon as practicable once the development has been completed.
