2000/2001 REVENUE ESTIMATES

With reference to the minutes of meeting of the Committee held on 15 September 1999 (Volume page 5052 refers) and of Council held on 22 December 1999 (Volume page 5413 refers) there was submitted report by the Director of Corporate Services (i) providing an update on the previously reported position in that the draft estimates exceeded the expenditure guideline by $\pounds 2,449,270$ and intimating that a deprivation allowance of $\pounds 1.011m$ had been awarded to the Council bringing the total expenditure guideline to $\pounds 148,330m$ and that the Council's Aggregate External Finance (AEF) had been increased to $\pounds 112.855m$ to accommodate the additional spending power generated by the deprivation allowance; and (ii) advising that the draft 2000/2001 revenue estimates had been compiled and produced in a volume format and were submitted for consideration by the Committee.

The Director of Corporate Services advised of 2 alterations to the report in that regarding (i) page 2 para.3.6. the page reference number should be '89' rather than '90' and (ii) appendix 2 and para 3.7. on page 2 as updated information was still being received from the Social Inclusion Partnership the figures shown were no longer reliable and the Director would issue the updated information to all members as soon as it was ready.

Councillor Devine, seconded by Councillor White, moved:-

The Committee notes with concern the unsatisfactory settlement imposed upon West Dunbartonshire Council.

Committee further notes that strong representations are being made to the Scottish Executive and an urgent meeting has been sought with the Minister of Finance at which the Council would be represented by the Leader of the Council, the Convener of the Finance Committee, the Chief Executive and the Director of Corporate Services.

Furthermore, the Finance Committee continues this report along with other budget issues to the meeting of the Council to be held on 9 March 2000.

The Committee also notes that the SNP would like to make representation to the Minister of Finance and will be advised of the Minister's response as to whether or not he is agreeable to this.
