Subject: Sustainable Development Strategy - Progress Report

1. Purpose

1.1 The purpose of this report is to provide information on the progress of the Sustainable Development Action Plan from 2008/09 to 2010/11.

2. Background

- 2.1 The Council made a commitment to producing a Sustainable Development Strategy as part of the Best Value Improvement Plan. The Sustainable Development Strategy 2008-2012 was approved at Corporate & Efficient Governance Committee in May 2008.
- 2.2 The duty of Best Value in the Local Government in Scotland Act 2003 requires that a local authority discharge its duties in 'a way which contributes to the achievement of sustainable development'. More recently, the Climate Change (Scotland) Act 2009 also requires that a public body, in exercising its functions, must act 'in a way it considers most sustainable'.
- 2.3 The common goal of sustainable development is to enable all people throughout the world to satisfy their basic needs and enjoy a better quality of life without compromising the quality of life of future generations. It acknowledges that our economic, social and environmental needs and goals are interdependent.

3. Main Issues

- 3.1 There are nine themes in the Sustainable Development Strategy covering the key areas which contribute to achieving sustainable development and echoing those themes found in Choosing Our Future the Scottish Government's Sustainable Development Strategy. The themes are: Transport and Travel; Built Environment; Natural Heritage and Resources; Waste; Well-Being; Food; Sustainable Communities; Our Global Contribution; and Learning about Sustainable Development.
- 3.2 A number of objectives were identified in the Strategy and from these the Action Plan was produced. The Action Plan has identified actions and performance indicators (PIs) from Departmental Services Plans and Operational Plans which contribute towards achieving the objectives of the Strategy.

- 3.3 This report reflects progress on the PIs identified as measuring progress in sustainable development from 2008/09 to 2010/11. The list of PIs are reviewed annually and updated as required, for example, a new indicator can be created which is relevant to measuring one of the objectives.
- 3.4 In general, good progress has been made against the majority of PIs signifying that the council is moving towards achieving the goals of sustainable development 17 out of 27 indicators are moving in a positive direction (a further 9 objectives need to have PIs developed to effectively measure them). Appendix A provides a full breakdown of progress by objective.
- 3.5 Where progress remains poor or indicators require to be developed this would have previously been addressed via the Sustainable Development Working Group. Due to ongoing restructuring, this Group isn't meeting at present so any areas of concern will be addressed through discussions between the relevant service and the Sustainability Officer.
