# Subject : Dumbarton Common Good Fund - Monitoring Report to 28 February 2011

### 1. Purpose

**1.1** The purpose of this report is to provide the Committee with details of income and expenditure on the Common Good Fund Account to 28 February 2011.

## 2. Background

**2.1** The 2010/2011 budget was agreed at a meeting of the Corporate and Efficient Governance Committee on 24 March 2010.

#### 3. Main Issues

3.1 A statement with the following information is attached:-

2009/2010 Final Outturn 2010/2011 Approved Budget 2010/2011 Actual Outturn to 28 February 2011 2010/2011 Projected Outturn

- **3.2** The total budgeted expenditure for 2010/11 is £238,500, as noted within the Appendix.
- **3.3** The statement shows projected income of £260,000 for the year.
- **3.4** When the projected expenditure and income are totalled, it is anticipated at present that the fund will have a net income of £21,500 this year.
- **3.5** When this balance is added to the 2009/10 balance carried forward of £131,814, it is forecast that £153,314 will be carried forward at 31 March 2011 for use in future years.

#### 4. People Implications

**4.1** There are no people implications.

#### 5. Financial Implications

**5.1** The current projection of expenditure to be paid in 2010/11 is £238,500, with £260,000 income anticipated. This leaves a forecast net increase to the Common Good Fund in 2010/11 of £21,500.

6.1 No additional risk analysis was required.

## 8. Conclusions and Recommendations
