## **WEST DUNBARTONSHIRE CHCP COMMISSIONING STRATEGY FOR REHABILITATION SERVICES: 2011-2021**

A report was submitted by the Partnership Director seeking approval of the Rehabilitation Commissioning Strategy.

Having heard the Partnership Director in further explanation of the report, the Partnership agreed:-

- (1) to approve the West Dunbartonshire CHCP Commissioning Strategy for Rehabilitation Services for 2011-2021; and
- (2) to commend the work of the CHCP staff involved in its development.

### **CARE INSPECTORATE INSPECTION REPORT – CRAIGELLACHIE CHILDREN'S UNIT**

A report was submitted by the Partnership Director summarising the last inspection report for Craigellachie Children's Unit received from the Care Inspectorate.

Having heard the Head of Children's Health, Care & Criminal Justice in answer to questions from a Member, the Partnership agreed:-

- (1) to note the positive content and grading achieved during the inspection; and
- (2) that, given the regularity of inspections at Residential Units within the West Dunbartonshire area, a report for Craigellachie Children's Unit would be submitted to the Partnership on an annual basis unless any of the findings of an inspection gave cause for concern.

### **CARE INSPECTORATE INSPECTION REPORT – RAMSAY CHILDREN'S UNIT**

A report was submitted by the Partnership Director summarising the last inspection report for Ramsay House Children's Unit received from the Care Inspectorate.

The Partnership agreed:-

- (1) to note the content and grading achieved during the inspection; and
- (2) that, given the regularity of inspections at Residential Units within the West Dunbartonshire area, a report for Ramsay House would be submitted to the Partnership on an annual basis unless any of the findings of an inspection gave cause for concern.

## **UPDATE ON CARE INSPECTORATE INSPECTION REPORTS FOR WDC OLDER PEOPLE RESIDENTIAL AND DAY CARE SERVICES**

- (3) that a progress report would be provided to the next meeting of the Partnership outlining further progress made in this regard.

## **CARE INSPECTORATE INSPECTION REPORTS FOR WEST DUNBARTONSHIRE COUNCIL SERVICES**

A report was submitted by the Partnership Director providing a summary of the Care Inspectorate (formerly Social Care and Social Work Improvement Scotland) inspection reports received for 4 Adult Support services and 2 Older People Residential services operated by West Dunbartonshire Council.
