#### **REVIEW OF SCHEME FOR THE ESTABLISHMENT OF COMMUNITY COUNCILS**

With reference to the Minutes of the Special Meeting of West Dunbartonshire Council held on 26 January 2011 (Page XXX refers), a report was submitted by the Executive Director of Corporate Services informing the Council of the response to the third consultation on the Scheme for the Establishment of Community Councils and making recommendations thereon.

The Council agreed:-

- (1) to approve the Revised Scheme for the Establishment of Community Councils, as detailed in Appendix I to these minutes, subject to the undernoted amendments:-

With respect to the written description of the boundary for Balloch and Haldane Community Council, replace the words “*along the A811 to Ballochmyle*” with “*along the A811 to Ballagan*”;

- (2) to approve the extended timetable for community council nominations and elections as shown on the attached timetable (shown as Appendix II to these minutes);
- (3) to agree that, in the interim, existing Community Councils should continue to operate as normal up until the close of nominations; and
- (4) to agree that if any Requisitions to form a new Community Council are received prior to timescales shown within the above timetable then the Requisition should be processed without delay and the nomination process undertaken under the statutory timescales. If sufficient numbers of nominations are received to form a community council but not enough to prompt an election, then the new community council would be constituted under the Revised Scheme. However, if an election is required then the election should be held at the same time as others, as detailed on the attached timetable.
